**APPLICATION UNDER THE FREEDOM OF INFORMATION ACT 1991**

I refer to your application made under the *Freedom of Information Act 1991* (the Act), dated 9 August, 2021.

Your application seeks access to:

*"The Government Gazette of 10 June 2021 reports the appointment of Leah Joy York to the Board of Funds SA. My understanding of section 9 – Establishment of the Board of the Superannuation Funds Management Corporation of South Australia Act 1995+ is that this appointment would have resulted from a decision made by the Treasurer following his receipt of a letter from an unincorporated association called The South Australian Government Superannuation Federation (the Federation). I am making this Freedom of Information application to obtain the following information about this letter. 1. What is the date on the letter? 2. What is the date of the letter's receipt in the Treasurer's Office? 3. What is the number of nominees made by the Federation in its letter? 4. Did the letter specify the process followed by the Federation in determining its nominees i.e. was the set of nominees approved at a general meeting, executive meeting or in some other way?"*

The purpose of this letter is to advise you of my determination. An extensive search was conducted within this office. A total of 2 documents were identified as answering the terms of your application.

I grant you access in part to 1 document; a copy of which is enclosed.  
I refuse you access to 1 document.

Document 1 contains personal information relating to contact details of the South Australian Government Superannuation Federation members, which has been redacted pursuant to clause 6(1).

Document 2 is an attachment to document 1 and is out of scope of the FOI application.

## Exemptions

### Clause 6 – Documents affecting personal affairs

- (1) *A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person.*

Please note, in compliance with Premier and Cabinet Circular PC045 - Disclosure Logs for Non-Personal Information Released through Freedom of Information (PC045), the Department of Treasury and Finance is now required to publish a log of all non-personal information released under the Act.

In accordance with this Circular, any non-personal information determined for release as part of this application, may be published on the DTF website. As I am determining this application as Principal Officer, section 29(6) of the Act does not provide for an internal review. If you are dissatisfied with my determination you are entitled to exercise your rights of external review with the Ombudsman.

Alternatively, you can apply to the South Australian Civil and Administrative Tribunal. If you wish to seek a review, section 39(3) of the Act states you must do so within 30 calendar days of receiving the determination.

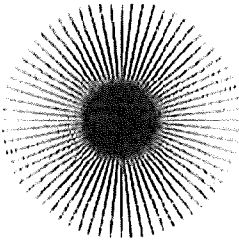

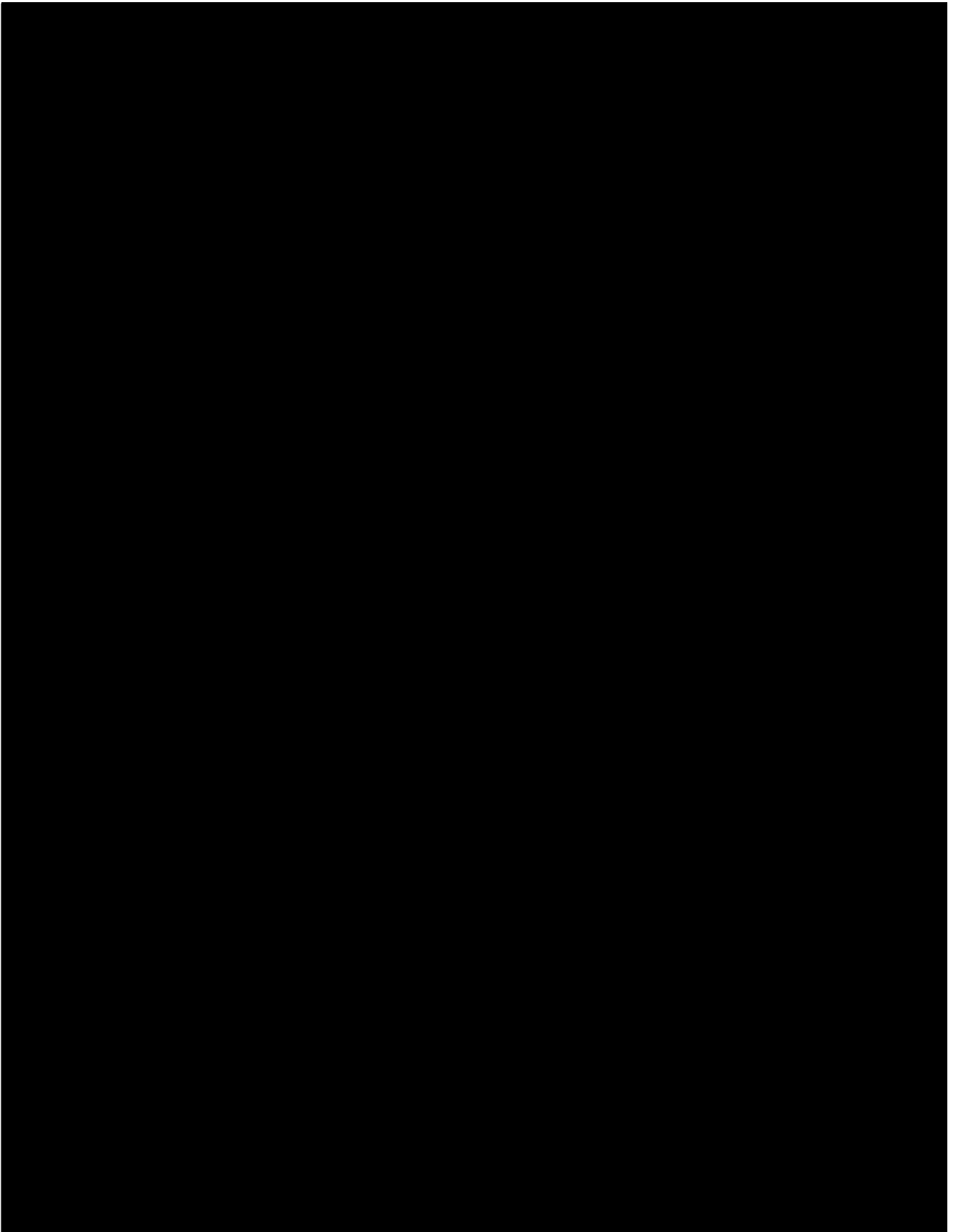
