**APPLICATION UNDER THE *FREEDOM OF INFORMATION ACT 1991***

I refer to your internal review application made pursuant to the *Freedom of Information Act 1991* (the Act) on 13 March 2023 in response to this agency's initial determination of a deemed refusal. As a determination was not finalised before the statutory 30-day time period required by the FOI Act, the original application was deemed refused under Section 9(2)(b) of the Act.

Your original application sought access to:

*"Screenshots of the Treasurer's official ministerial diary and/or register of appointments from Sunday 1 January 2023 to Friday 3 February 2023."*

I have made the following determination on internal review.

One document was identified within the scope of your request and I have determined to release this document in part.

I wish to advise that only entries which relate to the ministerial functions fall within scope of this request. Entries which relate to functions as a Member of Parliament do not fall within scope of your request as a Member of Parliament is not an 'agency' within the meaning the Act, accordingly, these entries have been removed as 'Out of Scope'.

The document contains entries such as reminders, appointments and events which are non-work related. As such, I consider it unreasonable to disclose information relating to the personal affairs of the Treasurer and third parties. I have therefore determined to exempt this information pursuant to clause 6 (1) of Schedule 1 of the Act.

In addition, the document contains information concerning the business and professional affairs of any other person. External businesses would expect a level of confidentiality regarding names of employees when meeting with the State Government. The name of the business remains within business meeting entries, however, the names of employees, when not a public figure are exempt. I have therefore determined to exempt this information pursuant to clause 7 of Schedule 1 of the Act.

## **Exemptions**

### **Clause 6 – Documents affecting personal affairs**

- (1) *A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead).*

### **Clause 7 – Documents affecting business affairs concerning**

- (1) *A document is an exempt document—*

*(c) if it contains matter—*

- (i) consisting of information (other than trade secrets or information referred to in paragraph (b)) concerning the business, professional, commercial or financial affairs of any agency or any other person; and*
- (ii) the disclosure of which—*
  - (A) could reasonably be expected to have an adverse effect on those affairs or to prejudice the future supply of such information to the Government or to an agency; and*
  - (B) would, on balance, be contrary to the public interest.*

- (2) *An agency must not give access under this Act to a document to which this section applies (except to the person concerned) unless the agency has taken such steps as are reasonably practicable to obtain the views of the person concerned as to whether or not the document is an exempt document by virtue of clause 7 of Schedule 1.*

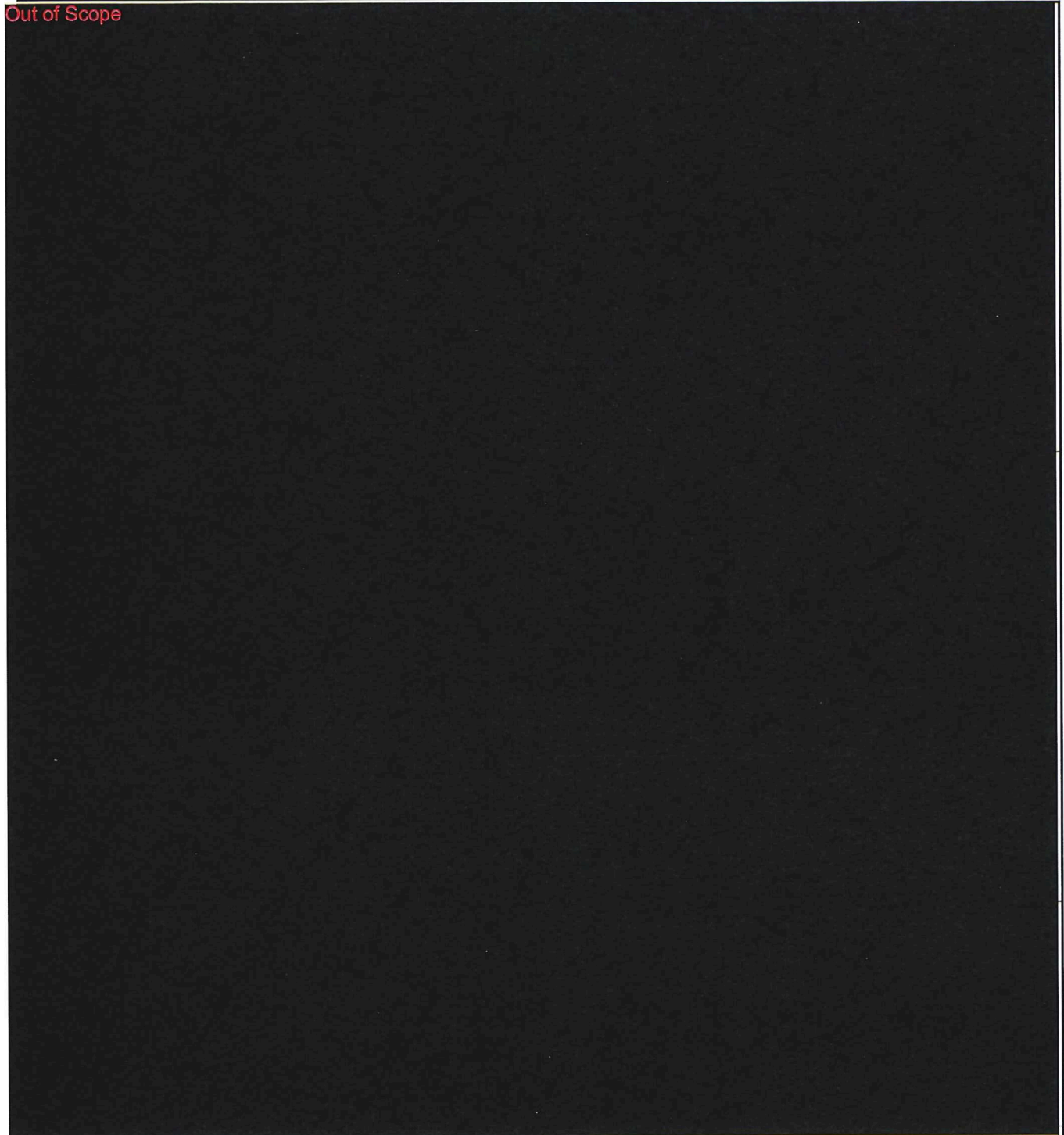
