Freedom of Information – Community Infrastructure Grants

I refer to your application under the *Freedom of Information Act 1991* (FOI Act), received by the Department of Treasury and Finance (DTF) on 25 July 2022

Your application specifically requested:

'I write seeking documents containing information under the Freedom of Information Act 1991. I specifically seek access to: 1. Documents/correspondence regarding the "Community Infrastructure Grant Program" including but not limited to; departmental memos, executive meeting minutes, emails, text messages, and ministerial briefing notes. 2. Documents/correspondence regarding the "Local Sporting Club Upgrades" program, including but not limited to; departmental memos, executive meeting minutes, emails, text messages, and ministerial briefing notes. 3. Documents/correspondence regarding the "Female Facilities" program, including but not limited to; departmental memos, executive meeting minutes, emails, text messages, and ministerial briefing notes. Date Range 20/03/2022 to 18/07/2022'

After communication with yourself, the scope was amended to the following:

I specifically seek access to:

- 1. Email and text message correspondence regarding the "Community Infrastructure Grant Program" sent/received between Monday June 6th and Friday July 29th 2022.*
- 2. Email and text message correspondence regarding the "Local Sporting Club Upgrades" program sent/received between Monday June 6th and Friday July 29th 2022.*
- 3. Email and text message correspondence regarding the "Female Facilities" program sent/received between Monday June 6th and Friday July 29th 2022*

Under the Act, an agency has 30 days to respond to a freedom of information request. As DTF did not respond to your request within the time frame required, the department is deemed to have refused you access to all documents relevant to your application. However, I have determined to process the request as if the statutory time frame had been met.

The purpose of this letter is to advise you of my determination.

A total of 28 documents were identified as answering the terms of your application and I have determined as follows:

- I grant you access in full to 2 documents, copies of which are enclosed
- I grant you access in part to 1 document, a copy of which is enclosed, and
- I refuse you access to 25 documents.

Please refer to the attached schedule that describes each document and sets out my determination and reasons in summary form.

Documents 6

This document contains information which, if released, would disclose details concerning a deliberation or decision of Cabinet and as such is exempt from release pursuant to clause 1(1)(e).

Documents refused in full

Documents 1 - 3, 7 - 8, 12 - 15, 17 – 21, 23 – 28

These documents consist of information which, if released, would disclose details concerning a deliberation or decision of Cabinet and as such is exempt from release pursuant to clause 1(1)(e).

Documents 4 – 5, 11

These documents are briefing papers specifically prepared for the use of the Treasurer in relation to matters submitted to Cabinet. I have therefore exempted these documents pursuant to clause 1(1)(f) of the FOI Act.

Documents 16, 22

These documents are briefing notes prepared specifically for use in Parliament, the disclosure of which would infringe the privilege of Parliament. I have therefore determined to exempt the document in full pursuant to clause 17(c) of Schedule 1 to the FOI Act.

Exemptions

Clause 1 – Cabinet documents

(1) *A document is an exempt document –*

...

(e) *if it contains matter the disclosure of which would disclose information concerning any deliberation or decision of Cabinet; or*

(f) *if it is a briefing paper specifically prepared for the use of a Minister in relation to a matter submitted, or proposed to be submitted to Cabinet.*

Clause 17 – Documents subject to contempt etc

A document is an exempt document if it contains matter the public disclosure of which would, but for any immunity of the Crown—

...
(c) *infringe the privilege of Parliament*

Please note, in compliance with Premier and Cabinet Circular PC045 - *Disclosure Logs for Non-Personal Information Released through Freedom of Information* (PC045), DTF is now required to publish a log of all non-personal information released under the *Freedom of Information Act 1991*.

Appeal Rights

If you are aggrieved with this determination, you have a right to apply for internal review under subsection 29(1) of the FOI Act. Pursuant to subsection 29(2), your application must:

- be in writing
- be accompanied by the application fee of \$39
- be addressed to the principal officer, and
- be lodged at an office of DTF, or emailed to freedomofinformation2@sa.gov.au within 30 days after the day on which you receive this letter or within such further time as the principal officer may allow.

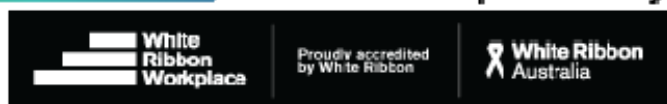
