Freedom of Information – Fleet SA speeding fines

I refer to your application under the *Freedom of Information Act 1991* (FOI Act), received by the Department of Treasury and Finance (DTF) on 21 February 2023.

Your application specifically requested:

'Access to a breakdown of all speeding fines received by Fleet SA vehicles between 19/03/2022 and 14/02/2023'

Section 4(6) of the FOI Act states 'An agency is not to be taken to hold a document while the document is held by or in the possession of an exempt agency for which the agency is responsible.'

The South Australian Government Financing Authority (SAFA) is an exempt agency as per Schedule 2 of the FOI Act. The Government of South Australia's passenger and light commercial motor vehicle fleet (Fleet SA) is owned and managed by SAFA.

The purpose of this letter is to advise you of my determination.

A total of 10 documents were identified as answering the terms of your application and I have determined as follows:

- I grant you access in full to 4 documents, copies of which are enclosed, and
- I grant you access in part to 6 documents, copies of which are enclosed.

Please refer to the attached schedule that describes each document and sets out my determination and reasons in summary form.

These documents consist of information relating to the personal affairs of public servants. Under clause 6(1) of Schedule 1 to the FOI Act, a document is exempt if its disclosure would involve the 'unreasonable disclosure of information concerning the personal affairs of any person'. This information falls within the definition of personal affairs under the FOI Act and is therefore exempt from release pursuant to clause 6(1).

Exemptions

Clause 6 – Documents affecting personal affairs


