Freedom of Information - Relocation of Wright Electorate Office

I refer to your application under the *Freedom of Information Act 1991* (FOI Act), received by the Department of Treasury and Finance (DTF) on 13 June 2018.

Your application specifically requested:

'All files, report, notes, emails and documents held by the agency relating to the relocation of the former Wright Electorate Office, from Suite 1, Golden Grove Shopping Centre to its current location at Lot 40 Old Port Wakefield Road, Virginia. A copy of the document ("memo") quoted by the Treasurer, Hon Rob Lucas MLC in Parliament on 17 May 2018 (Hansard Page 222). All files, reports, notes, emails and documents held by the agency relating to the document ("memo"), as quoted by the Treasurer, Hon Rob Lucas MLC in Parliament on 17 May 2018 (Hansard Page 222) to date'

Under the Act, an agency has 30 days to respond to a freedom of information request. As DTF did not respond to your request within the time frame required, the department is deemed to have refused you access to all documents relevant to your application. However, I have determined to process the request as if the statutory time frame had been met.

The purpose of this letter is to advise you of my determination.

A total of 22 documents were identified as answering the terms of your application and I have determined as follows:

- I grant you access in full to 11 documents, copies of which are enclosed
- I grant you access in part to 6 documents, copies of which are enclosed, and
- I refuse you access to 5 documents.

Please refer to the attached schedule that describes each document and sets out my determination and reasons in summary form.

Documents released in full

Documents 1 – 4, 11 – 13, 16 – 17, 19, 22

Documents released in part

Document 18 and 20

Sections not relevant to your application have been removed.

Document 10 and 14

These documents contains of information relating to the personal affairs of third parties. Under clause 6(1) of Schedule 1 to the Act, a document is exempt if its disclosure would involve the 'unreasonable disclosure of information concerning the personal affairs of any person'. I have therefore determined to exempt this information from release pursuant to clause 6(1) of the FOI Act.

Documents 15 and 21

Document 15 contains information about commercial properties and prices for renting these properties. The release of this information could have an adverse effect of these business and the State. Clause 7(1)(c) requires me to consider the public interest. In favour of release, I considered the public interest in government spending on accommodation. It is also clearly in the public interest that the agency properly discharges its functions and responsibilities.

It is contrary to the public interest to provide an advantage to one class of persons over others as such an advantage would be likely to reduce competition, leading to higher rental costs for the government. This in turn would be contrary to the public interest, as the agency is expected to maximise financial returns to the benefit of the state and its economy. The agency would therefore not be properly discharging its functions and responsibilities if it were to provide such an advantage. I have therefore determined that, on balance, it is contrary to the public interest to release this information and have exempted the information pursuant to clause 7(1)(c)

Document 21 contains active account numbers which form part of the business and financial affairs of a third party. If released there is a possibility some adverse effect could flow from their disclosure. As the release of this information is not likely to enhance participation by members of the public in the democratic process, but could possibly have some adverse effect on the third parties financial affairs, DTF considers that, on balance, it would contrary to the public's interest to release it. I have therefore exempted this information pursuant to clause 7(1)(c).

Documents refused in full

Documents 5 - 9

These documents consist of market calls for various electorate offices. If released this information could have an adverse effect of the businesses listed and the State. I have therefore exempted these documents pursuant to clause 7(1)(c) of the FOI Act.

Exemptions

Clause 6 – Documents affecting personal affairs

(1) A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead)

Clause 7 – Documents affecting business affairs

(1) A document is an exempt document—

(c) if it contains matter—

- (i) consisting of information (other than trade secrets or information referred to in paragraph (b)) concerning the business, professional, commercial or financial affairs of any agency or any other person; and
- (ii) the disclosure of which-
 - (A) could reasonably be expected to have an adverse effect on those affairs or to prejudice the future supply of such information to the Government or to an agency; and
 - (B) would, on balance, be contrary to the public interest.

Please note, in compliance with Premier and Cabinet Circular PC045 - *Disclosure Logs for Non-Personal Information Released through Freedom of Information* (PC045), DTF is now required to publish a log of all non-personal information released under the *Freedom of Information Act* 1991.

Appeal Rights

If you are aggrieved with this determination, you have a right to apply for internal review under subsection 29(1) of the FOI Act. Pursuant to subsection 29(2), your application must:

- be lodged at an office of DTF, or emailed to <u>freedomofinformation2@sa.gov.au</u> within 30 days after the day on which you receive this letter or within such further time as the principal officer may allow.

Hello Blair,

Thanks for your text message and discussion this morning (and last night).

I can confirm that I have had instructions from the Treasurer's office to facilitate the moving of the Member for King into the former Wright Electorate Office in the Golden Grove Village. As discussed, it is the intention of the Member for King to move into the office early next week. Can you please advise when you have boxed up the records and the equipment you have moved into the office ready to move out.

I can confirm that should you wish to store these items in temporary storage that Electorate Services will cover the short term costs of this. All office fit out is to remain. The former Taylor Electorate Office located in Virginia is also vacant and can be used for storage. It should also be noted that the office at Virginia is a fully functional electorate office and can be used to accommodate staff undertaking office based activity. Please let me know if you wish to pursue this option.

As previously discussed, utilising your office in Parliament House once operational to house your staff, or some of them, until new accommodation can be secured is also an option.

I can confirm that the recent market call undertaken in the Wright Electorate has identified the property you sent to me via text on the corner of Sunnybrook and the Golden Way. I have instructed our lease managers to make contact with the Agent asap to gather more details on the property and to arrange a site inspection. I will get back to you as soon as possible regarding this location. We are also looking at any other temporary accommodation opportunities that exist in or in close proximity to the Wright electorate.

Good morning Chris,

As discussed a short time ago, we are in the process of finalising the summaries for Mawson and Reynell and I will send these to you to once completed. In the meantime, please find attached the Market Call summaries for Colton, Lee, Black, Mackillop and Wright.

Whilst some of the market calls did not produce initial submissions, we have made further investigations to source some potential options within the Electorates requested.

In regards to the King Market call, both the initial request and subsequent investigations have not produced any suitable alternative accommodation options. Therefore we suggest that that existing Wright EO (located at Golden Grove) becomes the new King Office for the time being as this current lease expires 30 March 2019. This allows us some time to continue to investigate potential options as and when they become available, or negotiate a shorter renewal term.

Please do not hesitate to contact me should you have any questions relating to the summaries or particular properties that have been identified.

Once you have had an opportunity to review the information, it would be great to set up a meeting with you to go through the options and identify those that DTF wish to pursue further.

Hi Paula,

Clause 6 Kylie will email it to Steven and you shortly.

The facilities team are arranging a removalist to move Blair's items out of the new King EO. They will be out by cob Wednesday at the latest.

We will confirm a time with you for Thursday 12th April for the hand over. I suspect it will be me or Chris Evans mid to late morning. The mapping of IT will be dependent on the temporary arrangements for the new Wright EO. We will be discussing this with Parliamentary Network Support Group today. We will advise of the outcome when known. The new office phone number will be dependent on Telstra's actioning the request. We have placed a priority on this request.

Constituent files, and all office files created by the former Member for Wright are her personal property. She has given all the remaining records to Blair as the new Member for Wright. Should you wish to access these records, you will need to have that discussion with Blair. These documents are not considered records under the State Records Act and as such what happens to them is at the discretion of the Member.

You will need to set up your own new Post Office Box. The updated signage is a part of a broader schedule across a number of sites. The facilities team will be in contact with you regarding design, form, installation

etc in the near future. We are not aware of any dedicated parking associated with the lease however that's not to say that the former Member may have had an arrangement. Perhaps you can discuss this with the Centre Management (in suite 10) when you move in.

Key Points:

- The redistribution of electoral boundaries by the South Australian Electoral Commission
 has resulted in the following electorate offices being no longer within their new electoral
 boundaries; Hurtle Vale (ex Fisher), Davenport, Lee, Mawson, King (ex Napier), Black
 (ex Bright), Reynell, Taylor, Waite and Wright Electorate Offices.
- The redistribution has resulted in the following electorates having two offices in the one electorate. The electorates with two offices currently are: Elder (+ former Waite EO), Kaurna (+ former Mawson EO), Taylor (+ former Napier EO) and Port Adelaide (+ former Lee EO).
- Consideration to resolve Electorates with two offices:
 - o Elder remains where it is and the former Waite EO is closed.
 - o Kaurna remains where it is and the former Mawson EO is closed.
 - o Current Taylor EO is closed and relocated to the former Napier EO.
 - o Current Port Adelaide EO is closed and relocated to former Lee EO.

- Suitable tenancies for new electorate offices need to be identified, leased and fitted-out for the Reynell, Wright, Mawson, Lee and Black electorates.
- Considerations in opening new electorate offices:
 - o Availability of suitable commercial accommodation
 - o Time taken to locate, lease and fit-out
 - Some Members will be outside their electorate for a undetermined, possible lengthy period
- The opportunity to relocate one existing electorate office to another existing electorate
 office exists for Davenport to ex Fisher EO, Fisher (Hurtle Vale) to ex Reynell EO,
 Taylor to ex Napier EO, King to ex Wright EO, Waite to ex Davenport EO.
- Considerations in relocating existing EOs to existing locations:
 - All existing EOs are currently occupied (except former Waite EO and Taylor EO)
 - New Member for Hurtle Vale (Ex Fisher) will resist moving to the former Reynell EO which is currently in the new Mt Hurtle electorate boundary.
 - Move new Member for King into the former Wright EO and move former Wright EO into alternative (temp or permanent) accommodation; / or leave Wright EO where it is just inside King and find temporary accommodation for King EO until a more permanent solution can be found
 - Sequencing may require temporary accommodation outside the Member's electorate
- The former Finniss Electorate Office (Kingscote) may continue as a branch office of the new Mawson EO.
- The Member for Stuart intends to write to you requesting a relocation to a larger office in Pt Augusta to accommodate additional staff and other resources.
- The new Member for Waite has confirmed his desire to progress with previously approved site works in the electorate office he currently occupies in Blackwood. (the former Davenport EO).
- The former Treasurer has previously approved funding for office alterations at Waite Electorate Office (former Davenport EO) \$90k, relocation of Black Electorate Office (former Bright EO) \$150k and Reynell Electorate Office \$150k.
- The electorate offices of MacKillop and Colton are currently not compliant with Cabinet approved security measures and leasing arrangements are less than ideal.
- If all (10) electorate offices no longer situated within their electorate boundaries were granted approval to relocate to new office accommodation, an estimate of \$1.5M (\$150,000 per office) would be required for office fit-outs.

- As an estimate, a further \$0.5M would be needed for costs associated with the 'break and pay out' of existing leases, decommissioning works and other miscellaneous charges.
- The identification of suitable office accommodation within the new electorate boundaries
 for each electorate presents challenges. The availability of suitable locations is currently
 being investigated through open market calls for the electorates of Hurtle Vale, Black,
 Mawson, Reynell, Wright, King, Lee, Colton and MacKillop.
- It is recommended that you note the current state regarding accommodation for Members
 of the House of Assembly and the considerations in achieving the desired outcomes for
 office locations / relocations and Members requests.


