I write to request an internal review of Freedom of Information (FOI) applications T&F18/0248, T&F18/249, and T&F18/0250 made under the *Freedom of Information Act* 1991 (the FOI Act) to the Office of the Treasurer on 30 April 2018.

On 21 May 2018, I received a letter from Mr David Reynolds, Principal Officer of the Department of Treasury and Finance determining an extension of time for these applications.

Applications for external review - Freedom of Information Act 1991 Mullighan and The Treasurer

I refer to previous correspondence about your applications for external review relating to a letter purporting to extend the time by which your applications under the *Freedom of Information Act 1991* (the FOI Act) are to be determined by the Office of the Treasurer.

The reviews concern a letter from Mr David Reynolds, Principal Officer of the Department of Treasury and Finance, dated 21 May 2018. The letter purports, pursuant to section 14A of the FOI Act, to extend the time for dealing with the applications. Section 14A(1) mandates that an extension of time determination be made by the Principal Officer of an agency. The Principal Officer for the Office of the Treasurer is Mr Rob Lucas and as such any determination pursuant to section 14A should have been made by Mr Lucas. I am therefore of the view that the 21 May 2018 letter is not a valid determination pursuant to section 14A of the FOI Act. I have informed the Treasurer of this view.

This means that the original time limit for determining your claim applies. As the agency has failed to determine your applications within 30 days of receipt, it is deemed to have determined the applications by refusing access to the documents (section 19(2)(b) of the FOI Act). I advise that you are entitled to apply for internal review of those deemed determinations.



External review - Freedom of Information Act 1991 Mullighan and The Treasurer

I refer to previous correspondence in relation to these external reviews under section 39 of the *Freedom of Information Act 1991* (the FOI Act).

These external reviews relate to three Freedom of Information applications made by Mr Mulligan MP, the applicant, originally to the Department of Treasury and Finance (DTF). By email dated 2 May 2018, the applicant was advised by the FOI Officer of DTF that a decision had been made to transfer the applications (pursuant to section 16(1)(a) of the FOI Act) to the Office of the Treasurer.

The reviews concern a letter from Mr David Reynolds, Principal Officer of DTF, dated 21 May 2018. The letter purports, pursuant to section 14A of the FOI Act, to extend the time for dealing with the applications. Section 14A(1) mandates that an extension of time determination be made by the Principal Officer of an agency. As you have acknowledged in your letter dated 6 July 2018, you are the Principal Officer for the Office of the Treasurer and as such any determination pursuant to section 14A should have been made by you. I am therefore of the view that the 21 May 2018 letter to the applicant is not a valid determination pursuant to section 14A of the FOI Act.

I note your statement that although you were not aware of the letter of 21 May 2018, you support the decision to extend the period of time by which the applications are to be determined. I advise that a valid extension of time determination 'must be effected by giving written notice of the extension to the applicant within 20 days after the application is received' (section 14A(3)). I am of the view that you cannot now adopt the decision purportedly made by Mr Reynolds, as the time by which such a determination is to be made has passed.

It is my view therefore that the notice purportedly given to the applicant under section 14A is invalid and the original time limit applies.

I therefore intend to advise the applicant that he is eligible to apply for internal review as your agency is deemed to have refused him access to the documents sought by reason of section 19(2)(b) of the FOI Act.

I confirm that there is no Instrument of Delegation to Mr Reynolds to act as the Principal Officer on my behalf.

A review of this matter has identified that there has been an administrative error which has resulted in the DTF Principal Officer, Mr Reynolds, making the section 14A determination instead of myself as Principal Officer for the Office of the Treasurer. I am advised that the person employed as an FOI Officer in DTF, is responsible for DTF FOI applications and assists my office with FOI applications addressed to the Office of the Treasurer. In this particular instance, the correspondence from Mr Mullighan was provided by the FOI Officer to Mr Reynolds which has resulted in Mr Reynolds inadvertently signing the determination.

Having identified this administrative error, my office is reviewing the processes in relation to FOI applications addressed to the Office of the Treasurer to ensure that future determinations that are required under the Act to be signed by the Principal Officer of the Office of the Treasurer are brought to my attention.

Although I was not aware of the determination, I am advised by the DTF FOI unit that the determination to extend the period which the applications would be determined to 23 August 2018 was based on the following information:

• The Office of the Treasurer would be required to search through 2,800 - 3,000 documents per application, including the emails of all staff, network drives and the Objective records system;

• At this stage, the Office of the Treasurer have identified 50 - 80 documents that fall within the scope of each application some of which require consultation with external parties.

In any event, after considering this information, I support the determination made by Mr Reynolds to extend the period to 23 August 2018.



'Any documents, minutes, briefings, emails, notes or correspondence provided to the Treasurer or to his office between 14 April and 30 April 2018 inclusive, from the following agencies: - Department of Treasury & Finance - Revenue SA - Super SA - Funds SA - Shared Services SA - Fleet SA - Motor Accident Commission of South Australia - South Australian Government Financing Authority - Essential Services Commission of South Australia - Lotteries Commission of South Australia - Local Government Finance Authority of South Australia - South Australian Water Corporation'.

Under s14A of the Act, I have determined that the time limit to respond to your applications has been extended to 23 August 2018. The extension is required as a preliminary assessment indicates that the applications involve access to a large number of documents and dealing with the applications within the 30 calendar days would unreasonably divert the agency's resources from exercising its functions.

External review

If you wish to appeal this determination to extend the time limit, you can apply to the Ombudsman for an external review under section 39 of the Act. An application for external review must be made within 30 calendar days from the date you receive this letter. Freedom of Information applications refs: T&F18/0248, T&F18/0249, and T&F18/0250

I refer to your letter of 21 May 2018 about Freedom of Information (FOI) applications, made under the *Freedom of Information Act 1991* (FOI Act), and your determination to extend the time limit to respond under section 14A of the FOI Act.

More than two weeks ago (Friday 4 May, 2018) I discussed these FOI applications with your FOI Officer, Ms Natalie Haigh. Ms Haigh raised her concern that the scope of each FOI application would result in a large number of documents being captured and suggested that I refine the scope of my application.

Ms Haigh advised me that, as the applications sought access to all documents, including documents beyond minutes and briefings from the Department of Treasury and Finance (DTF) to the Treasurer and Office of the Treasurer, a large number of documents were likely to be captured. Ms Haigh described these documents as "mundane" and implied they were beyond the intent of each application.

I advised Ms Haigh the FOI Act entitles applicants to seek access to any documents held that match the description of each application, unless they were specifically exempted under the provisions of the FOI Act. It is not for anticipation or interpretation what should, or should not, be captured by each request unless by express agreement between applicant and agency (as has been the long-standing practice of DTF, and the Office of the Treasurer, as agencies under the FOI Act, in determining applications).

Notwithstanding this, I indicated to Ms Haigh that I was willing to refine the scope of the application to reduce the number of documents captured. In doing so, however, I sought from her some indication the original scope of each application would capture a large number of documents (and hence enable the agency to trigger s14A (1)(a) of the FOI Act). I asked Ms Haigh what number of documents an initial search had discovered, to which she indicated that such an initial search had not been undertaken. As such, an estimate of the number of documents captured by each application could not yet be made.



I suggested to Ms Haigh if she could advise me of an estimate of the number of documents likely to be captured, and if this estimate demonstrated that the original scope captured too many documents and would hence be too onerous for the agency to complete the determination within the required period, then I would refine my scope accordingly.

The phone conversation ended on this basis. Again, you will note this process of discussion and refinement has been the long-standing practice of DTF, and the Office of the Treasurer, as agencies under the FOI Act, in determining applications.

To my surprise, the next communication about the applications I receive is your letter, referred to above. As you may imagine, I am bemused at the treatment of the three applications thus far.

The applications were made on 30 April 2018. Receipts for each application were emailed to me that day (attached). On 2 May 2018, I was advised the applications were received by DTF on 1 May 2018, and were being transferred from the DTF to the Office of the Treasurer, under section 16 (1)(a) of the FOI Act (see enclosed email).

However, your letter of 21 May 2018 is addressed from you as the principal officer (presumably of DTF), under section 4 of the FOI Act. Are you also the principal officer of the Office of the Treasurer, a separate agency under the FOI Act to DTF?

In addition to this, in the absence of an estimate of the number of documents captured by each of the applications, as discussed and agreed upon with your FOI Officer, your determination to extend the time limit to 23 August 2018 appears unreasonable.

Whilst I understand that on occasion some FOI applications may be onerous on agencies to determine, given the breadth of the documents sought, I do not believe that is the case with each of these three separate applications.

Each application was made separately. Despite correspondence received to date from DTF dealing collectively with all three, each application should be dealt with separately.

Further, each application was for access to documents over a very narrow date range – only 2 weeks (or a maximum to 10 business days), greatly limiting the number of documents able to be captured by each request.

In the absence of any search being conducted and number of documents being established (as agreed to with Ms Haigh), and advice received accordingly, coupled with the failure to provide an opportunity to narrow the scope of each application (as agreed), your determination as communicated is unreasonable.

I ask that you reconsider your determination.
