1.1. Gross Sales

June 2018 - Gross sales were \$38.518M - \$2.030M or 5.56% above the estimated result.

FY 2017-18 -- Gross sales were \$458.613M -- \$28.805M or 6.70% above the estimated result.

1.2. Commission

June 2018 – The average commission paid to agents was 7.47% of gross sales compared with the estimated result of 7.47%.

FY 2017-18 - The average commission paid to agents was 7.51% of gross sales compared with the estimated result of 7.48%.

1.3. Prizes

June 2018 – Prize expenditure was \$22.504M – \$0.680M or 3.12% above the estimated result.

FY 2017-18 - Prize expenditure was \$277.092M - \$19.677M or 7.64% above the estimated result.

1.4. Goods and Services Tax (GST) on Net Gambling Revenue (NGR)

June 2018 – GST on NGR paid to the Federal Government was \$1.456M, 9.23% above the estimated result.

FY 2017-18 - GST on NGR paid to the Federal Government was \$16.502M, 5.30% above the estimated result.

1.5. Operating Expenses (before Interest and Depreciation)

June 2018 - Operating expenses were \$0.066M - \$0.042M or 38.89% less than the estimated result.

FY 2017-18 - Operating expenses were \$0.926M - \$0.426M or 31.51% less than the estimated result.

1.6. Return to State Government

June 2018 – Return to State Government was \$6.410M – \$0.197M or 3.17% above the estimated result.

FY 2017-18 – Return to State Government was \$75,789M – \$2.696M or 3.69% above the estimated result.

June 2018 – The Return to Government payments are made via the Hospitals Fund (99.81%) and the Recreation and Sport Fund (0.19%).

FY 2017-18 – The Return to Government payments are made via the Hospitals Fund (99.79%) and the Recreation and Sport Fund (0.21%).

NB. FY 2017-18 figures are still to be audited by the Auditor-General's Department and any material variations will be reported.
