**APPLICATION UNDER THE *FREEDOM OF INFORMATION ACT 1991***

I refer to your application made under the *Freedom of Information Act 1991* (the Act), received 14 August 2020.

Your application seeks access to:

*"All documents and records in relation to reimbursements by the Treasurer and Ministerial staff for purchases made using the Treasurer's Credit Card, Chief of Staff's Credit Card, or Treasurer's Office Manager's credit card from 15 March 2014 and 16 March 2018."*

The purpose of this letter is to advise you of my determination. An extensive search was conducted within this office. A total of 1 document was identified as answering the terms of your application.

I grant you access in part to 1 document; copy of which is enclosed.

The date range within the scope of your request sought documents between the 15 March 2014 and 16 March 2018. I understand you have also sent an application to the Department of Treasury and Finance (DTF) as I understand DTF may also hold documents within your date range.

**Released in Part**

Document 1 is released in part as it contains credit card information relating to the financial affairs of the Government. I therefore determine this information exempt pursuant to clause 7(1)(c).

## Exemptions

### Clause 7 – Documents affecting business affairs concerning

- (1) A document is an exempt document—
- (c) if it contains matter—
- (i) consisting of information (other than trade secrets or information referred to in paragraph (b)) concerning the business, professional, commercial or financial affairs of any agency or any other person; and
  - (ii) the disclosure of which—
    - (A) could reasonably be expected to have an adverse effect on those affairs or to prejudice the future supply of such information to the Government or to an agency; and
    - (B) would, on balance, be contrary to the public interest.

Please note, in compliance with Premier and Cabinet Circular PC045 - *Disclosure Logs for Non-Personal Information Released through Freedom of Information* (PC045), the Department of Treasury and Finance is now required to publish a log of all non-personal information released under the Act.

In accordance with this Circular, any non-personal information determined for release as part of this application, may be published on the DTF website. A copy of PC045 can be found at the following address: <https://dpc.sa.gov.au/resources-and-publications/premier-and-cabinet-circulars>. Please visit the website for further information.

As I am determining this application as Principal Officer, section 29(6) of the Act does not provide for an internal review. If you are dissatisfied with my determination you are entitled to exercise your rights of external review with the Ombudsman.

Alternatively, you can apply to the South Australian Civil and Administrative Tribunal. If you wish to seek a review, section 39(3) of the Act states you must do so within 30 calendar days of receiving the determination.
