Freedom of Information – VALO Adelaide 500 State Dinner

I refer to your application under the *Freedom of Information Act 1991* (FOI Act), received by the Department of Treasury and Finance (DTF) on 18 January 2023.

Your application specifically requested:

'Please provide all documents, including but not limited to emails, text messages, and any other forms of correspondence, regarding any expenditure on the VALO Adelaide 500 State Dinner held on Friday 2 December 2022. [Date range: 01/07/2021 – 18/01/2023]'

Under the Act, an agency has 30 days to respond to a freedom of information request. As DTF did not respond to your request within the time frame required, the department is deemed to have refused you access to all documents relevant to your application. However, I have determined to process the request as if the statutory time frame had been met.

The purpose of this letter is to advise you of my determination.

A total of 38 documents were identified as answering the terms of your application and I have determined as follows:

- I grant you access in full to 20 documents, copies of which are enclosed, and
- I grant you access in part to 18 documents, copies of which are enclosed.

Please refer to the attached schedule that describes each document and sets out my determination and reasons in summary form.

Documents released in full

Documents 1, 3-4, 7, 9-10, 13, 15-16, 19, 21-22, 24-25, 27-28, 31, 33-34 and 37

Documents released in part

Documents 2, 5-6, 8, 11-12, 14, 17-18, 20, 23, 26, 29-30, 32, 35-36 and 38

These documents contain the mobile phone number and residential addresses of third parties. Under clause 6(1) of Schedule 1 to the FOI Act, a document is exempt if its disclosure would involve the 'unreasonable disclosure of information concerning the personal affairs of any person'. This information falls within the definition of personal affairs under the FOI Act and is therefore exempt from release pursuant to clause 6(1).

Documents 2, 5, 8, 11, 14, 17, 20, 23, 26, 29, 32, 35 and 38 provide details of the rates and costs charged by Hughes Chauffeur Service. Disclosing the rates charged by Hughes Chauffeur Service has the potential to cause commercial damage to the Chauffeur Service, it is likely that competitors could use this information to gain a competitive advantage over Hughes Chauffeur Service.

In addition, document 38 contains the account details for Hughes Chauffeur Service which forms part of their business and financial affairs. The account details remain active. If released there is a possibility some adverse effect could flow from their disclosure.

I acknowledge that it is very much in the public interest to disclose the amounts spent by government. However, I believe this is outweighed by the need to ensure that companies doing business with the government is not disadvantaged by the release of information relating to costs associated with their business. I have therefore determined to exempt this information pursuant to clause 7(1)(c) of Schedule 1 of the FOI Act.

Exemptions

Clause 6 – Documents affecting personal affairs

(1) A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead).

Clause 7 – Documents affecting business affairs

(1) A document is an exempt document— ...

(c) if it contains matter—

(i) consisting of information (other than trade secrets or information referred to in paragraph (b)) concerning the business, professional, commercial or financial affairs of any agency or any other person; and

(ii) the disclosure of which—

(A) could reasonably be expected to have an adverse effect on those affairs or to prejudice the future supply of such information to the Government or to an agency; and

(B) would, on balance, be contrary to the public interest.

Please note, in compliance with Premier and Cabinet Circular PC045 - *Disclosure Logs for Non-Personal Information Released through Freedom of Information (PC045)*, DTF is now required to publish a log of all non-personal information released under the *Freedom of Information Act 1991*.

Appeal Rights

If you are aggrieved with this determination, you have a right to apply for internal review under subsection 29(1) of the FOI Act. Pursuant to subsection 29(2), your application must:

- be in writing

- be lodged at an office of DTF or emailed to freedomofinformation2@sa.gov.au within 30 days after the day on which you receive this letter or within such further time as the principal officer may allow.
