Freedom of Information – Meetings between Chief Executive and the Office of the Treasurer

I refer to your application under the *Freedom of Information Act 1991* (FOI Act), received by the Department of Treasury and Finance (DTF) on 15 June 2018.

Appeal Rights


If you are aggrieved with this determination, you have a right to apply for internal review under subsection 29(1) of the FOI Act. Pursuant to subsection 29(2), your application must:
