### **Freedom of Information – Future Jobs Fund**

I refer to your application under the *Freedom of Information Act 1991* (FOI Act), received by the Department of Treasury and Finance (DTF) on 30 May 2018.

Your application specifically requested:

*'All minutes, briefings, notes, emails and correspondence from the Department of Treasury and Finance to the Treasurer and the Treasurer's Office regarding any grants and loans under the Future Jobs Fund initiative'*

Under the Act, an agency has 30 days to respond to a freedom of information request. As DTF did not respond to your request within the time frame required, the department is deemed to have refused you access to all documents relevant to your application. However, I have determined to process the request as if the statutory time frame had been met.

The purpose of this letter is to advise you of my determination.

A total of 17 documents were identified as answering the terms of your application and I have determined as follows:

- I grant you access in full to 1 documents, copies of which are enclosed
- I grant you access in part to 5 documents, copies of which are enclosed, and
- I refuse you access to 11 documents.

Please refer to the attached schedule that describes each document and sets out my determination and reasons in summary form.

### **Documents released in full**

Document 7

### **Documents released in part**

Document 1 – 2, 5, 9, 12 and 15

These documents contain information about business who have applied for grants from the Future Jobs Fund. These applications are still undergoing assessment and/or negotiation of final terms. To release the information at this time would provide competing companies with knowledge of their competitors plans for future development.

When considering factors contrary to the public interest, I took into account the unfair advantage releasing this information may provide to other companies, as it would be likely to reduce competition, which would lead to higher costs and less job creation for the South Australian economy. This would be contrary to the public interest, as the agency is expected to maximise financial returns to the benefit of the State and its economy. The agency would therefore not be properly discharging its functions and responsibilities if it were to provide such an advantage. I have therefore determined that, on balance, it is contrary to public interest to release this information and have exempted it under clause 7(1)(c) of the FOI Act.

Document 1, 2 and 15

These documents contain information which, if released, would disclose details concerning a deliberation or decision of Cabinet. I have therefore determined to exempt this information pursuant to clause 1(1)(e).

### **Documents refused in full**

Documents 3 – 4, 16 – 17

Under clause 10(1) of Schedule 1 to the Act, information is exempt from disclosure if it would be privileged from production on the ground of legal professional privilege. These documents consist of legal advice provided to the government by its legal advisor, the Crown Solicitor, information which is subject to legal professional privilege. I have therefore determined to exempt these documents pursuant to clause 10(1).

Documents 6, 8, 10 – 14

These documents consist of information about business who have applied for grants from the Future Jobs Fund. These applications are still undergoing assessment and/or negotiation of final terms. To release the information at this time would provide competing companies with knowledge of their competitors plans for future development.

As previously stated, it would be contrary to public interest to release this information and I have therefore determined to exempt these documents pursuant to clause 7(1)(c) of the FOI Act.

### **Exemptions**

#### **Clause 1 – Cabinet documents**

(1) *A document is an exempt document –*

...

(e) *if it contains matter the disclosure of which would disclose information concerning any deliberation or decision of Cabinet;*

#### **Clause 7 – Documents affecting business affairs**

(1) *A document is an exempt document—*

...

(c) *if it contains matter—*

- (i) consisting of information (other than trade secrets or information referred to in paragraph (b)) concerning the business, professional, commercial or financial affairs of any agency or any other person; and
- (ii) the disclosure of which—
  - (A) could reasonably be expected to have an adverse effect on those affairs or to prejudice the future supply of such information to the Government or to an agency; and
  - (B) would, on balance, be contrary to the public interest.

#### **Clause 10 – Legal Professional Privilege**

- (1) A document is an exempt document if it contains matter that would be privileged from production in legal proceedings on the ground of legal professional privilege.

Please note, in compliance with Premier and Cabinet Circular PC045 - *Disclosure Logs for Non-Personal Information Released through Freedom of Information* (PC045), DTF is now required to publish a log of all non-personal information released under the *Freedom of Information Act 1991*.

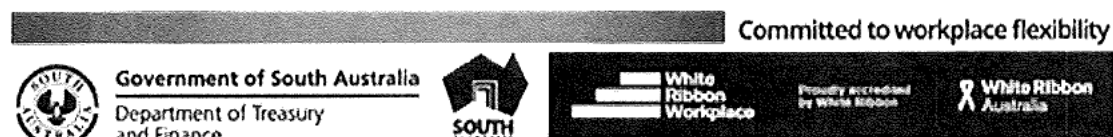

**Future Jobs Fund grants to NDIS providers - Queries****Background & Context****Clause 1(1)(e)**

Advice to SAFA from the Department for Industry and Skills is that the disability sector is undergoing major structural change as the NDIS represents a shift from block-funding disability services, equipment and housing providers, to an individual fee-for-service arrangement. The Scheme provides for people with disabilities to design their own care plans to determine the type, level and frequency of support they need, including who will provide this support. In this scenario the money follows the individual, unlike the earlier funding model where block funding went to an organisation and they provided services for free. Pricing for services is set by the National Disability Insurance Agency (NDIA)

The NDIS also aims to meet previously unmet need and funding has doubled (Commonwealth and State matched funding) to support this increased demand. Therefore, a wider range of services are expected to be sought by a larger population of people with disability. The current supply chain does not have capacity to meet the growing demand as the Scheme moves to full implementation by 2019.

**Future Jobs Fund Grant Deeds - General Terms**

A standard form of Grant Deed has been prepared by the Crown Solicitor's Office (under instruction from SAFA) for grants awarded from the Fund. The Grant Deed (deed) is consistent with the Fund Guidelines.

Under the terms of the deed, grants are to be applied specifically to the Projects that were considered by the Fund Governance Committee and approved by the previous Minister for State Development. The deed provides that grants are paid in instalments upon satisfaction of agreed performance milestones and evidence of expenditure on the Project of at least twice the amount claimed.

The deed prescribes employment outcomes consistent with the jobs growth asserted by successful applicants to the Fund. The deed provides for express pro-rata clawback of the grant should employment targets not be achieved within a reasonable timeframe.

Amongst other provisions in the deed, grantees must give the Treasurer full details of any financial assistance for activities in connection with the Project which it expects or receives from another Commonwealth, State or Territory government source or agency during the term of the deed, including the amount and source of the funding and the name of the program under which it was provided, within thirty (30) days of receiving notice that the other financial assistance has been approved. The deed provides that the Treasurer may reduce the size of the grant instalments to reflect the amount of the other financial assistance provided.

**The Benevolent Society – Grant of \$2,300,000 (plus GST) Grant Deed executed on 22 April 2018.**

The Benevolent Society was founded in 1813. It is based in New South Wales, and currently provides services to disadvantaged people in NSW and Queensland.

The State's Future Jobs Fund grant of \$2.3M is for it to establish services in South Australia under the NDIS in ten regions. The State's deed provides that it is to establish itself as an NDIS provider, and deliver services to clients with intellectual disability and global developmental delay, which include physiotherapy, speech therapy, dietetics, occupational therapy, behaviour therapy, psychology, and nursing.

The grant may be claimed in instalments subject to the Society achieving the following performance milestones and providing evidence of expenditure for the purposes of the Project of at least twice the amount claimed:

- Established a South Australian office by June 2018
- Services are established in the Limestone Coast, Mid North and Yorke by June 2019
- Services are established in eastern, southern and western Adelaide by June 2020
- Services are established in Murray Mallee, Western Eyre, Far North and Fleurieu regions by June 2021

Under the terms of the deed it is to create 230 new full-time employees (FTE) by 30 June 2022. Failure to meet annual FTE growth Targets out to financial year 2021-22 will result in pro-rata clawback of the grant.
