APPLICATION UNDER THE FREEDOM OF INFORMATION ACT 1991

I refer to your application made under the *Freedom of Information Act* 1991 (FOI Act), dated 9 May 2019.

Your application seeks access to:

"All minutes, briefings and correspondence titled 'Funding Supplementation and Expenditure Authority for Relocation of the Colton Electorate Office' as described on the Objective document management system, between 12 July 2018 and 9 May 2019."

The legislative prescribed timeframe to determine this application has expired and is now deemed to have refused you access to all documents relevant to your application. I refer to my letter dated 26 May 2019 where I sought additional time to make my determination.

The purpose of this letter is to advise you of my determination. An extensive search was conducted within this office. A total of 1 document was identified as answering the terms of your application.



Key Points:

- The existing Colton Electorate Office is situated at the 318 Seaview Road, Henley Beach.
- The Colton Electorate Office is currently on a monthly holding over leasing arrangement.
- The Department of Planning, Transport and Infrastructure (DPTI) has recently advised Electorate Services that the building owner has chosen not to continue these leasing arrangements beyond 30 September 2019.



- Following the advice from your office that you had provided in principle approval to relocate the Colton Electorate Office, Electorate Services requested DPTI undertake a market call for office accommodation within the new electorate of Colton.
- Market call submissions for consideration included 476 Tapleys Hill, Fulham Gardens and tenancy options within Henley Square Pavilion 330 Seaview Road, Henley Beach. In addition DPTI sourced the following options for consideration 322 Seaview Road, Henley Beach, 504 Henley Beach Road, Fulham, 438 Henley Beach Road, Lockleys and Shop 2A, 130 Valetta Road, Fulham Gardens.
- The option most aligned to electorate office requirements, following an inspection of all sites and the preferred office option of the Member for Colton is Shop 2A, 130 Valetta Road, Fulham Gardens.
- The Chief Executive has authorised the Memorandum of Administrative Arrangement (MOAA) between DTF and DPTI, accepting the negotiated lease terms and conditions for Shop 2A, 130 Valetta Road, Fulham Gardens.

Area:

110m² (subject to final survey)

Rental:

\$31,900 per annum (\$290/per m2) plus GST

Outgoings:

included in gross rental.

Lease commencement:

1 April 2019 or completion of lessee works, whichever is

earlier.

Rent commencement:

1 June 2019

Lease term:

4 years, with a 4 year right of renewal

- Funding supplementation of \$150,000 (\$120,000 capital, \$30,000 operating) for the Support Services to Parliamentarians budget is sought for the 2018-19 financial year for the relocation of the Colton Electorate Office to Shop 2A, 130 Valetta Road, Fulham Gardens.
- The relocation of this office will also result in increased rental charges and ongoing funding supplementation of \$11,900 per annum is also sought for the increase in rental costs.
- DTF, Budget and Performance Branch has been consulted in relation to this proposal and should you approve this request, will make the necessary budget adjustments. It is not possible for these costs to be absorbed within the existing budget.
- It is recommended that you consider approving funding supplementation and expenditure authority for the Support Services to Parliamentarians budget for the 2018-19 financial year and ongoing, to appropriately fund the relocation of the Colton Electorate Office to Shop 2A, 130 Valetta Road, Fulham Gardens.
