I refer to your application made under the *Freedom of Information Act* 1991 (FOI Act), dated 3 January 2020.

"All minutes, briefings and correspondence titled 'Leader of the Opposition – 2019-20 Budget Allocation' as described on the Objective document management system, between 17 July 2019 and 3 January 2020."

The legislative prescribed timeframe to determine this application has expired and is now deemed to have refused you access to all documents relevant to your application. I refer to my letter dated 22 January 2020 where I sought additional time to make my determination.

The purpose of this letter is to advise you of my determination. An extensive search was conducted within this office. A total of 1 document was identified as answering the terms of your application.

I grant you access in full to 1 document; a copy of which is enclosed.



Key Points:

- The Leader of the Opposition is granted an annual budget allocation from the DTF, Administered Item Support Services to Parliamentarians.
- The base budget allocation for the 2018-19 financial year was \$1.534M, with an additional \$264K of unspent funds carried over from 2017-18.
- The Leader of the Opposition's budget allocation has historically been increased by 2.5% each financial year. This would result in an increase of \$38K, bringing the base budget allocation for 2019-20 to \$1.572M.
- It is not possible to provide a carryover amount at this point in time, as final expenditure figures for 2018-19 are not yet available.
