APPLICATION UNDER THE FREEDOM OF INFORMATION ACT 1991

I refer to your application made under the *Freedom of Information Act 1991* (the Act), dated 31 May 2023 and your Internal Review Application dated 5 July 2023.

Your applications seek access to:

"A copy of all documents (including but not limited to hard copy or electronic briefings, minutes, reports, emails, letters (including draft versions), meeting agendas, diary entries and any other correspondence) in relation to credit rating agencies Moody's, Standard & Poor's, and Fitch."

Determination under review

My office did not make a determination on your initial application within the 30-day time period required by the Act. Accordingly, my office was deemed to have refused access in full to all documents relevant to your application.

Outcome of internal review

Under section 29(3) of the Act, on an application for internal review, as Principal Officer, I may confirm, vary or reverse the determination under review.

I am varying the original determination of a deemed refusal.

An extensive search was conducted within this office, with a total of six (6) documents found that fall within scope of your application:

- I grant you access in full to two (2) documents; copies of which are enclosed.
- I grant you access in part to three (3) documents; copies of which are enclosed.
- I refuse you access in full to one (1) document.

Refused in Full

I have refused access to document 4 under clause 17(c) of Schedule 1 of the Act.

Clause 17 – Parliament Documents

17—Documents subject to contempt etc

A document is an exempt document if it contains matter the public disclosure of which would, but for any immunity of the Crown—

(c) infringe the privilege of Parliament.

Document 4 is a Parliamentary Briefing Note which was prepared specifically for use in Parliament, the disclosure of which would infringe the privilege of Parliament. I have therefore determined exempt this document in full pursuant to clause 17(c) of Schedule 1 to the FOI Act.

Released in Part

I have granted partial access to documents 3, 5 and 6 under clause 6(1) of Schedule 1 of the FOI Act.

Clause 6 – Documents affecting personal affairs

(1) A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead).

Information redacted in documents 3, 5 and 6 refers to mobile phone numbers that appear in the email. Whilst the mobile numbers appear in the public servant's signature block, it is difficult to determine whether the mobile number is used solely for work purposes or mixed employment and personal use. The ability for an individual to be contacted outside of their ordinary work hours is unreasonable. Moreover, the Ombudsman has ruled that mobile numbers constitute the personal affairs of the individuals concerned¹. Therefore, in line with the Ombudsman determination, the mobile numbers are exempt pursuant to clause 6(1) of Schedule 1 to the Act.

Please note, in compliance with Premier and Cabinet Circular PC045 - *Disclosure Logs for Non-Personal Information Released through Freedom of Information* (PC045), the Department of Treasury and Finance (DTF) is now required to publish a log of all non-personal information released under the Act.

For your information, Moody's have issued an comment/note on the financial position of state government's following the release of mid-year budgets.

The main themes are that temporary COVID related expenditures (mainly health) are taking longer than expected to be unwound. It also flags the risk that rising interest rates combined with increasing debt burdens (ie debt affordability) could impact the credit profiles of some states over the next four years.

The focus of the note is really on NSW and Victoria. South Australia is not specifically mentioned, but is included in the relevant interstate comparisons.
