Freedom of Information Internal Review — Leader of the Opposition expenditure

I refer to your Freedom of Information application received by the Department of Treasury and Finance on 3 May 2019 and your Internal Review application received on 4 July 2019

Your application specifically requested:

'Receipts, invoices, reimbursements and any other documents relating to all expenditure for entertainment, catering and overseas travel for Steven Marshall MP and any member of the Leader of the Opposition's staff between 4 March 2013 and 18 March 2018'

After consultation with your office, this scope was amended to:

'Monthly summary for each month, broken down into expenditure lines for entertainment, catering and overseas travel for the date range to 1 January 2016 to 18 March 2018 for Steven Marshall MP and any member of the Leader of the Opposition's staff'

Determination under review

DTF did not make a determination on your initial application within the 30-day time period required by the Freedom of Information Act 1991 (the Act). Accordingly, DTF was deemed to have refused access in full to all documents relevant to your application.

Outcome of internal review

Under section 29(3) of the FOI Act, on an application for internal review, as principal officer I may, confirm, vary or reverse the determination under review. In doing so, I am required to give fresh consideration to the decision under the FOI Act

I have determined to **vary** the original deemed refused determination.
