APPLICATION UNDER THE FREEDOM OF INFORMATION ACT 1991

I refer to both of your applications made under the Freedom of Information Act 1991 (the Act), dated 13 February 2020.

Your applications seek access to:

"Copies of all statements of the Office Manager's credit card in the Office of the Treasurer between 15 March 2014 and 16 March 2018."

"Copies of all invoices and receipts of charges against the Office Manager's credit card in the Office of the Treasurer between 15 March 2014 and 16 March 2018."

The legislative prescribed timeframe to determine these applications have expired and is now deemed to have refused you access to all documents relevant to your applications. However, I have determined to process both requests as if the statutory timeframe had been met.

The date range within the scope of your requests sought documents between the 15 March 2014 and 16 March 2018. The only documents held in this office date from 31 January 2018 to 16 March 2018, but as advised in my letter dated 7 March 2020, I partially referred both of your applications to the Department of Treasury and Finance (DTF) as I understood DTF may also hold documents within your date range.

The purpose of this letter is to advise you of my determination. An extensive search was conducted within this office. A total of 2 documents were identified as answering the terms of your applications.

I grant you access in part to 2 documents; copies of which are enclosed.

Documents released in part

Documents 1 and 2 are released in part as these contain details of a credit card number. These invoices have been redacted as it contains information relating to the financial affairs of the Government. I therefore determine this information exempt pursuant to clause 7(1)(c).

Exemptions

Clause 7 – Documents affecting business affairs concerning

- (1) A document is an exempt document—
 - (c) if it contains matter—
 - (i) consisting of information (other than trade secrets or information referred to in paragraph (b)) concerning the business, professional, commercial or financial affairs of any agency or any other person; and
 - (ii) the disclosure of which—
 - (A) could reasonably be expected to have an adverse effect on those affairs or to prejudice the future supply of such information to the Government or to an agency; and
 - (B) would, on balance, be contrary to the public interest.

Please note, in compliance with Premier and Cabinet Circular PC045 - *Disclosure Logs for Non-Personal Information Released through Freedom of Information* (PC045), The Department of Treasury and Finance is now required to publish a log of all non-personal information released under the Act.

In accordance with this Circular, any non-personal information determined for release as part of this application, may be published on the DTF website. No fees and charges are payable for this application.

As I am determining this application as Principal Officer, section 29(6) of the Act does not provide for an internal review. If you are dissatisfied with my determination you are entitled to exercise your rights of external review with the Ombudsman.

Alternatively, you can apply to the South Australian Civil and Administrative Tribunal. If you wish to seek a review, section 39(3) of the Act states you must do so within 30 calendar days of receiving the determination.
