Freedom of Information Internal Review — Incoming Government Briefs and correspondence

I refer to your Freedom of Information application received by Department of Treasury and Finance on 16 April 2018 and your Internal Review application received on 23 May 2018.

Your applications specifically requested:

'Any and all incoming government briefs (including but not limited to physical or electronic briefs, emails and any other correspondence) from or for any entity forming part of the organisational structure of the agency, including the Chief Executive, the Minister or any of the Minister's staff [Date: 15 March 2018 to 13 April 2018]'

Determination under review

DTF did not make a determination on your initial application within the 30-day time period required by the Freedom of Information Act 1991 (the FOI Act). Accordingly, DTF was deemed to have refused access in full to all documents relevant to your application.

Outcome of internal review

A total of 188 documents were identified as answering the terms of your application and I have determined as follows:

- I grant you access in full to 23 documents, copies of which are enclosed
- I grant you access in part to 124 documents, copies of which are enclosed, and
- I refuse you access to 41 documents.

Please refer to the attached schedule that describes each document and sets out my determination and reasons in summary form.

Exemptions

- (a) *if it is a document that has been specifically prepared for submission to Cabinet (whether or not it has been so submitted); or*
 - (b) *if it is a preliminary draft of a document referred to in paragraph (1); or*
 - (c) *if it is a document that is a copy of or part of, or contains an extract from, a document referred to in paragraph (a) or (b); or*
 - (e) *if it contains matter the disclosure of which would disclose information concerning any deliberation or decision of Cabinet; or*
 - (f) *if it is a briefing paper specifically prepared for the use of a Minister in relation to a matter submitted, or proposed to be submitted to Cabinet*

Clause 6 – Documents affecting personal affairs

- (1) *A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead).*

Please note, in compliance with Premier and Cabinet Circular PC045 - *Disclosure Logs for Non-Personal Information Released through Freedom of Information (PC045)*, DTF is now required to publish a log of all non-personal information released under the *Freedom of Information Act 1991*.
