### APPLICATION UNDER THE FREEDOM OF INFORMATION ACT 1991

I refer to your application made under the *Freedom of Information Act 1991* (FOI Act), transferred to my office on 1 August 2018.

Your application seeks access to:

"All files, reports, notes, emails and documents held by the office of the Hon Rob Lucas MLC (Treasurer, Minister for Finance) Ministerial Office relating to the Wright Electorate Office, from 17 March 2018 to date."

The legislative prescribed timeframe to determine this application has expired and is now deemed to have refused you access to all documents relevant to your application. However, I have determined to process the request as if the statutory time frame had been met.

The purpose of this letter is to advise you of my determination. An extensive search was conducted within this office.

A total of 21 documents were identified as answering the terms of your application and I have determined as follows:

I grant you access in full to 10 documents, copies of which are enclosed; and I grant you access in part to 6 documents, copies of which are enclosed; and I refuse you access to 5 documents.

Please refer to the attached schedule that describes each document and sets out my determination and reasons in summary form.

#### Dear

Thank you for your email about the current location of the electorate office of the Member for Wright currently located outside the new electorate boundary. I apologise for the delay in responding.

The redistribution of electoral boundaries in 2016 by the South Australian Electoral commission resulted in number of electorate offices not being located within the new electoral boundaries.

The former Treasurer was advised in March 2017 that the redistribution of electoral boundaries would impact on several Members of the House of Assembly's electorate offices and that funds should be allocated as part of the 2017-18 Budget to assist with these relocations. However, the Treasurer at the time decided to defer this decision to after the March 2018 election. As a consequence there are a number of electorates where the elected Member has no office in their immediate electorate.

I have consistently applied the principle where relocations are required due to electoral boundary changes that the Member who has an office in their electorate is entitled to utilise that office. As you aware, in the case of the electorate office located at the Grove Shopping Centre, following the boundary redistribution, this office is now situated in the electorate of King, not Wright and occupied by the Member for King, Ms Paula Luethen.

I have recently approved the establishment of an electorate office at the Manor Farm Shopping Centre, 53 Northbri Avenue, Salisbury East for use by the Member for Wright. The market call conducted throughout the electorate of Wright highlighted the scarcity of appropriate office accommodation in this electorate, and these premises were identified through a physical search of the electorate. The Member for Wright has been continually consulted through the search process and has advised that he is well acquainted with the Manor Farm Shopping Centre site.

I hope this information clarifies the current situation for you.

Dear Treasurer,

I write again regarding the location of the Wright Electorate Office (EO).

I understand that options for a new Wright EO will be presented for your consideration shortly. I would like to stress again the importance of having an electorate office that is both central in geographical terms, and well serviced by public transport.

Although the Manor Farm option at Salisbury East is a good short-term option, it does not meet the criteria above, as advised in my previous correspondence to you. For residents of Modbury Heights, Wynn Vale, Surrey Downs and Redwood Park (65% of Wright constituents) to travel to Manor Farm via public transport would require them to catch 3 buses; taking 86-minutes one way (Source: *Adelaide Metro: Plan My Journey*).

As has been noted previously, sites identified by Electorate Services in Wynn Vale and Surrey Downs were leased before Crown negotiations could be finalised. There is not an abundance of appropriate vacant office space in the seat at this time. That is why I am asking for consideration of a 12-month lease to be entered into with the owners of Manor Farm. This will allow for Electorate Services to continue to search for an appropriately located and accessible office whilst maintaining an office in the seat.

I look forward to being provided further information at your earliest convenience.

- approve additional funding supplementation and expenditure authority for the Support Services to Parliamentarians budget of \$150,000 for the initial fit out works for the new Wright Electorate Office.

## **Key Points:**

 The 2016 redistribution of electoral boundaries by the South Australian Electoral Commission resulted in the electorate of Wright no longer having an electorate office within the new electoral boundary.



- Post the 2018 State Election, the new Member for Wright, Mr Blair Boyer MP, was temporarily located in the former Wright Electorate Office (now King) within The Grove Shopping Centre for a short period prior to the Member for King moving into the office on 12 April 2018. The Member for Wright has been temporarily located in the former Taylor Electorate Office, Old Port Wakefield Road, Virginia since 11 April 2018.
- Several market calls to identify accommodation suitable for both long term ongoing and short term temporary office space were undertaken pre and post the 2018 State Election. The scarcity of suitable accommodation has resulted in failed discussions / negotiations with leasing agents in relation to properties in Surrey Downs, Salisbury East, Redwood Park and Wynn Vale. Investigations indicated that the sites identified were considered either not fit for purpose, represented poor value, required significant works / additional fitout expenditure or a suitable lease could not be achieved.
- The establishment of a temporary electorate office does not come without considerable cost. A temporary office needs to meet Cabinet approved security requirements, have data and communications installed and maintained, fitout of furniture and business operations areas, suitable heating and cooling system for the tenancy, as well as access to suitable bathroom facilities. In addition to lease / rental costs, the fitout of a temporary electorate office in temporarily leased premises is estimated to be at least \$50,000 in costs to the tenant. It is not possible to provide comment on lessor base building works until a site is identified.
- Negotiations with the Lessor of the Manor Farm Shopping Centre, 53 Northbri Avenue, Salisbury East have been productive with a lease proposal being received from the lessor on 3 July 2018. Electorate Services sought a lease proposal for both a one year with an additional one year option, to facilitate a temporary arrangement, as well as a lease proposal for a four year with an additional four year option as a longer term arrangement.
- Department of Planning, Transport and Infrastructure: Development Division Property, has received an initial lease proposal from Gilbert Kym Falland and John Rothwell Grosse, for Tenancy 2, Manor Farm Shopping Centre: 53 Northbri Avenue, Salisbury East:

Area: 130m² (subject to final survey)

Rental: \$36,000 per annum (\$277 per m²) plus GST

Outgoings: included in gross rental.

Lease commencement: 1 October 2018 or completion of lessor works

Lease term: 4 years, with a 4 year right of renewal

- The lessor has advised he is not willing to enter into a one year lease arrangement for this tenancy. The lessor as a part of a four year lease proposal has committed to significant lessor works including installation of new reverse cycle ducted air conditioning, extending the tenancy by an additional 30 square metres resulting in an approximate total floor space of 130 square metres, internal disability accessible bathroom facilities, new floor coverings, dedicated car parking and multiple signage opportunities. The gross rental rate offered is competitive in the current market, in addition to a one off discount and considering the lessor works committed to, represents good value.
- Electorate Services has worked cooperatively with the Member and has kept him abreast
  of progress with discussions regarding all electorate office accommodation investigated.
  He has on several occasions, the most recent being in a letter to you dated 4 July 2018
  (copy attached), expressed his view that the tenancy at Northbri Avenue, Salisbury East
  is not centrally located enough within his electorate and not well serviced by public
  transport. He has reiterated that it is his view that Manor Farm Shopping Centre should

only be used as a temporary site for 12 months until accommodation more centrally located is found. As detailed above, the Lessor of Manor Farm Shopping Centre is not willing to enter into a one year lease arrangement for this tenancy.

- The Member emailed me previously raising his "real concerns about the accessibility of Manor Farm by public transport". He asserts that the Manor Farm Shopping Centre "is serviced by one bus route. To get there by bus from the southern part of the seat (where about 65% of residents live) is three different buses and as much as 80 minutes." The Member reinforces his view that "I would refer a short term tenancy at Manor Farm that provides the option of finding somewhere both central and better accessed by public transport down the track."
- Electorate Services has undertaken some further investigation on public transport routes in the Wright Electorate that indicates that traversing the electorate from north to south in either direction is complicated, often requires changes of bus and required investment of travel time of the quantum's suggested by the Member. The travel time suggested by the Member is replicated in many other Electorates where constituents have to travel to see their local Member. It is the view of Electorate Services that the travel requirements suggested for a portion of the electorate would not be a sufficient reason not to favourably consider establishing the new Wright Electorate Office at Manor Farm Shopping Centre subject to a 4 year lease.
- The location of the Manor Farm site has come about as a result of exhaustive searches for accommodation within the Wright Electorate. Negotiations with the Lessor have resulted in an office of suitable size, quality infrastructure, signage opportunities and in a location that is accessible. The Member has publicly stated his desire to urgently move into an Electorate Office inside the Wright electorate and the Manor Farm Shopping Centre is located firmly within the northern portion of his electorate.
- Further investigation of temporary options will only further delay the Member for Wright's relocation to a site within the electorate.
- The current lease at the Virginia site has been extended to 4 November 2018 with an option for a further 6 month option to extend to the 4 May 2019. Should a lease be entered into at Manor Farm Shopping Centre, the Lessor estimates his works will be completed by approximately October 2018. It is expected that the fitout and commissioning of the new Wright Electorate Office would be completed prior to the expiry of an extended lease at the Virginia Electorate Office.
- It is recommended that you approve additional funding supplementation and expenditure
  authority for the Support Services to Parliamentarians budget of \$150,000 for the initial fit
  out works for the new Wright Electorate Office. Annual rental charges and outgoings are

Hello Julian,

Summary of this afternoons meeting regarding the possible location for the Wright Electorate Office – Manor Farm Shopping Centre - 53 Northbri Avenue, Salisbury East

The building owners agent and architect attended the meeting along with the lease negotiator / lease manager from DPTI and representatives from Electorate Services (Paul Tatarelli and Chris Evans)

- Electorate Services confirmed with the agent that she would respond to lease proposals for both a 1 year lease plus a 1 year extension option (temporary solution) and a 4 year lease with a 4 year extension option (ongoing solution). The agent indicated that the lessor is not keen on a 1 year lease and intimated that this would be reflected in the amount of lessor works he would complete and the price per square metre charged (in the higher range). No timeframe was given for the lessors response to the lease proposal. (Estimate a couple of weeks)
- The lease proposal lessor works for the 4 year lease with a 4 year option includes: accessible toilet inside the tenancy, ducted RC air conditioning, lighting, floor coverings, extension to front of office, signage opportunities, disability access compliance. The architect will need time to produce options for extension and inside toilet options (2 options discussed) to enable a costing and timeframe to be finalised. The architect indicated that if all requirements proceeded without delays, the lessor works could possibly be completed by early October 2018.
- Architect advised that the lessor had approached the Salisbury Council regarding approval of the
  works. The Council have indicated a short turnaround time and indicated the proposal would not
  need to go out for consultation thus speeding up the process.
- The Architect undertook to complete his drawings as quickly as possible to enable a costing to be produced. He had already completed some drawings and will use the information provided in today's meeting to further progress the costing.
- I met with Blair Boyer on Thursday 21 June to update him on progress with lease negotiations. I reaffirmed with him that Electorate Services was seeking lease proposals for a 4 plus 4 year lease (ongoing option) and a 1 plus 1 year lease (temporary option) The Member indicated his preference was not to be in Salisbury East and would prefer to be in and around Wynn Vale, Surrey Downs, Modbury Heights. (in closer proximity to the former Wright EO and on more frequently

services public transport routes. I restated we have not been able to find any suitable sites and that we continue to look.

• The agent advised that the Member had been in contact with her seeking information regarding time frames for negotiations, duration of leases, details of future meetings so he could attend. I advised the agent that should she receive approaches from the Member in future, these are to be referred directly to myself or DPTI lease management.

#### Issues for further consideration:

A one year lease with a 1 year option is highly likely to result in a per square meter rental far exceeding market prices

There would be no guarantee that the option would be available to exercise after 1 year. (Lessor seeking longer term tenants)

The fit out costs for a temporary office would be predominantly sunk costs as little of the fitout would be used elsewhere.

The likelihood of finding alternative office space and effect a move within 1 year would be very difficult (close to impossible given recent experience) to achieve

There are still no government owned buildings inside the Wright electorate available for occupation. Seeking a 4 year lease will encourage the lessor to undertake more works, reduce costs to DTF for fitout, provide a fully functioning / compliant Electorate Office, improved value for money per square meter leasing rate.

Please advise if you have any further questions. I will update when a response from the lessor to our lease proposals has been received.

It is with some dismay that I find that I now have to travel to Virginia to see my elected member. Before the electoral boundary change I was in the electorate of Newland which was very convenient to me when I needed help from my member. During the past few years my parents both died which necessitated quite a bit of paperwork. My father finally succumbed to his WW2 war service injuries/illnesses leaving my mother (his life partner of some 76 years). I had to have copies of his Will and codicil as well as the power of attorney documents which all needed to be certified by a JP. Michael from the Newland electorate was very helpful in that he photocopied all the relevant copies and then signed them for us. There were some 40 pages to be certified. Some 6 months later my mother died and we had to repeat the process. It is hard enough to deal with the loss of parents without having to wonder who is oing to be available to help us.

When I expressed my concerns to your office staff that if I, or other people, needed to have a similar service I would have to travel to Virginia to have it done I was told that the member would come to me or I could go to my local library. As I doubt the library would photocopy any documentation without charge, this could place a financial burden on those wishing for assistance.

There is no bus service to Virginia. That an elected member of Government who is so far out of his electorate has no public transport access for those in need is simply appalling. It begs credibility and is quite ludicrous that in this day and age no acceptable office space in the electorate of Wright is available.

## TALKBACK ITEMS SCANNED FROM LAST NIGHT

(6pm-6am)

Blair Boyer, Member for Wright (5AA 21.16-21.23) His electorate office / Being the Member for Wright (Cordeaux: Blair Boyer kept on popping up on the program last night ... he's on the line ... you're going to get that office because I had the Premier ring about ... 11:50 last night to say they're working on it, you'll get your office. So don't get too attached to the campervan) Well I'm trying not to although it is proving fairly popular ... people like the campervan, so I might have to find a way of keeping it somehow (Cordeaux: ... stack it out the front of the office) I could do that ... I've even put snags on for people, that's the beauty of having the motorhome; I can take the barbie around and put a cup of tea on for people as well. It does have its upside (Cordeaux: Well, feed them, stroke them, talk to them, charm them – you can't go wrong) I'm trying to do all those things (Cordeaux: Good boy ... anyway, it's nice to talk to you. I didn't know much about you when your name came up on the program last night) ... I'm a newbie, so only recently elected at the March election for the seat of Wright ... and I ... had a few people who were listening to your program last night who called me to say the Premier had come on to talk about the situation with my office and I was keen to get on and provide a bit more context around what happened. Because the current situation is not a great one, being out in Virginia ... which is 25km away from the people I represent and no real prospects ... of being able to find myself an office in the area ... the way I came to have this motorhome was I ... put out a call on Facebook asking people if they had a caravan or motorhome they could loan me because I wanted to still get out and meet residents ... and a very kind resident of the north-east suburbs got in touch and ... said I'd be welcome to borrow it (Cordeaux: Is Virginia outside your electorate?) It's 25km outside the electorate ... it's a long, long way away ... not remotely close ... the most common reaction I've had when I've told residents where my office is, they laugh because they assume it's a joke ... I have to explain ... your MP is now in Virginia (Cordeaux: Steven assures me they're on the case and it will be fixed. But ... the people around Virginia are lovely people ...) ... I have nothing against Virginia ... it's just a

matter of me being able to.. (Cordeaux: Do your job) ... which is all I want to do. I am pleased to hear the Premier say last night that it's going to be fixed soon, I really hope it is. As much as I love the motorhome I'd like to have a bricks and mortar office too (Cordeaux: Do you get to choose where the office is or does somebody in the bureaucracy ...) It's a bit of both ... they put out ... a market call ... asking real estate agents for expressions of interest on what properties they have available and they sit down with the MP and say ... would you be happy to be in one of these offices, is it what you're looking for in terms of location ... so it's a bit of both really (Cordeaux: ... you need a place where people can come and talk to you) ... I do and it needs to be accessible ... it's important that's easily accessible through public transport (Cordeaux: Are you one of these modern politicians ... I think it speaks very, very well of a politician ... who says here's my phone number, call me any time you need my help ... are you that kind of politician?) I am ... (Cordeaux: Well bless you) That's exactly what I say to people and ... all through the election campaign ... I told people you can call me direct on my own number, and I was a little nervous about how that was going to go ... but people have been really respectful ... and I like to be able to answer it and help them with their queries straight away if I can rather than them contacting my office or writing to me. So it works well. But ... the downside can be the expectation you build up is you are always reachable and will always answer your phone [Talk over each other] (Cordeaux: It's an expectation but ... it's a reasonable expectation if you want to be in public life ... you have to talk the talk and walk the walk ...) ... I've had some very good conversations with people and sometimes people just call because they want a bit of a chat and ... that's sometimes how you find out what's happening in your area ... so I've been pleased with how it works and ... it's the way the world has gone, it's people's expectation now and ... not many people were surprised ... when I told them I'm providing you with my personal mobile phone number and you can call me ... most people accepted ... that's what should be done now, so that's what I'm doing (Cordeaux: ... if I was going to give you ... advice ... I would say you are literally campaigning not when they announce the election, you are campaigning for the next four years ...) ... when you asked me am I modern politician ... yes I am, but in other respects I think I'm not and what I try to do is knock on doors. I think even if this age of social media ... the best thing you can do is knock on somebody's door and speak to them. It is still the thing they ... appreciate the most (Cordeaux: ... what's your ambition?) I was fully prepared ... to be unemployed right now, before the election ... (Cordeaux: What were you doing before the election?) I worked for the then Premier Jay Weatherill ... and I was very realistic about my chances of winning the seat. So right now I'm very, very pleased I am gainfully employed as the Member for Wright and I have no ambitions beyond that ... I'm really grateful I got the opportunity at all (Cordeaux: Well ... we're all public servants ...) ... that's what I'm trying to do, even in a motorhome at the moment (Cordeaux: ... let me know when you get the office) I will ... thanks for your time (Cordeaux: All the best, Blair)

Steven Marshall, Premier (5AA 23.48-23.52) Electoral offices

(Cordeaux: Mr Premier, you're burning the midnight oil) Absolutely. Just home from Parliament House. It was a longish night tonight. We've just started a week in Parliament, so this week and next week we'll be sitting. So just got home and was listening to your program as per usual; it's always great, Jeremy (Cordeaux: Thank you. You settling into the job? It is what you thought it would be?) We're in our 11<sup>th</sup> week now. It's ... early times for the new Government but there's plenty of work to do and we're really enjoying it, enjoying the challenge, there's plenty of opportunity and we're up for the task (Cordeaux: Yeah ... when I saw your name pop up on the screen I thought you wanted to talk about the trees, but you want to talk about the electoral office) There was a lot of confusion about the electoral office and I thought I would just clear it up. Every Member of course should have his or her

office in the electorate, I think that's only fair to the members of the electorate so that they can get their MP as conveniently as possible, and that is certainly the intention of the new Government. But I make the point that the previous government knew what the electoral boundaries were for a very, very long period of time, so they knew that they were going to be changing on the 17th of March this year and made no efforts whatsoever to create new offices within the electorates. So unfortunately the Member for Wright, Blair Boyer, doesn't have an office in his electorate; that will be rectified as quickly as possible. But that was the situation that was caused by the previous government not the new Government; we've only been in for a couple of weeks. The previous government knew for months if not years what those new boundaries would be and they should've made plans to establish offices within the new electoral boundary [phone breaks up] (Cordeaux: Steven if you find yourself at a loose end, but being Premier you're never going to do that I guess, but we'd love you to come in and just have a chat and take some calls) Well that would be my great pleasure. I would absolutely love that (Cordeaux: Well we'd be honoured if you could fit us in somehow. I know how busy you are) Oh no. It's an honour to be the Premier of South Australia. It's an awesome responsibility and I take it very, very seriously and I'd love to come in to your studio and speak to your listeners and answer questions as openly and as honestly as I can (Cordeaux: And in this weather it's kind of like a fireside chat. I think they go down rather well) [Laughs] That would be absolutely great ... and congratulations on your program, I listen to it often. You've got great listeners who have got great issues that they want to raise, they care about South Australia as we all do. This is the greatest state in Australia, and the greatest country in the world (Cordeaux: Well it's the Court of Public Opinion and we all depend upon it)100% (Cordeaux: Thank you, Sir)

## RADIO TALKBACK ITEMS OF INTEREST

<u>Blair Boyer, MP for Wright</u> (ABC RADIO ADELAIDE 17.34-17.45) Electorate boundaries redistribution: MP working out of motorhome / Claims of political bastardry

(Schiller: Due to a redistribution of electoral boundaries Blair Boyer, the Member for Wright, was asked to setup a temporary electoral office in Virginia, 20ks out of his electorate. Blair has instead decided to use a motorhome to see his constituents ... how did you end up having your office in a motorhome ...) due to the redistribution where they changed the boundaries of the State electorate, the Electorate for Wright which is the Seat that I represent, the office that had been there for 20 years at the Golden Grove Village was no longer in that seat, it was just outside ... by about 370 metres ... (Schiller: are you serious ...) we measured it ... (Schiller: are people not able to walk from one electorate to the other ...) this is the bizarre rule that seems to have been imposed by the new Treasurer, Jules, is that you must have your office within the electorate ... when it's 370 metres out of the electorate you represent no-one cares ... when I was doorknocking during the campaign many people asked me and said 'If you're successful where do you intend of having your office? Will you keep it at the Golden Grove Village?' And I always said, 'If I win, I intend on keeping it at the same place,' which is where people wanted it ... after the election I was called by the new Member for King which is a new seat which now takes in The Village and the neighbouring suburbs of Golden Grove and Greenwith ... I knew that The Village was just in her electorate ... she told me she didn't want to have her office there, she wanted something more visible and that if I wished to keep the electorate office for Wright at the Golden Grove Village I could do so ... that's the advice that ... Electorate Services ... provided to the Treasurer, I moved in, we got the keys and then ... a few days later we were told that because the Member for King couldn't find something else we were going to have to be booted out and she was

going to be moving in and we got moved out to Virginia. (Schiller: Okay, and how far is Virginia out of your Electorate of Wright?) 25kms ... actually a bit more from some parts of the seat ... it's a long way ... there's a couple of routes to get there from where I live and on one of those routes you actually travel through four other electorates before you get to Virginia from the Seat of Wright ... (Schiller: how did you get to a motorhome ...) I was wracking my brains ... about what I do ... I knew that I couldn't expect residents to travel 25kms to Virginia to see me ... I was keen to make sure I still represent them ... thought about a motorhome, put it up on Facebook ... asking if people had a caravan or something like that they could loan me and had a very, very generous resident in the north east contact me and said ... she'd seen the story, felt sorry for me, had a motorhome she wasn't using and she'd give it to me to use as long as I needed. (Schiller: Okay, so is a motorhome like a caravan?) It is except it's like ... actually attached to the truck ... which is great because it means I don't have to tow anything ... (Schiller: are you legally able to park it and be in office?) That's a very, very good question. I don't know but we have chosen spots around the electorate ... the empty car parks, the football clubs and places like that ... so that people can easily come and see me there without me disrupting any traffic ... (Schiller: have you got signage up there, Blair Boyer ...) I have ... (Schiller: has it got beds and things in it, Blair? Can you sleep in it?) It does ... it's a got a little stove and a microwave and a fridge and a bed ... (Schiller: sanitation issues, you ... have to empty the toilet and things like that, is that something that you need to do, Blair?) All staff are under strict orders not to use the toilet facilities so we don't have to do any cleaning ... (Schiller: why can't you just take out a lease on an office building within your Seat of Wright?) That is a very good question and one that I've been asking ... yes, there is probably not a huge range of options for me in terms of empty office space but there are some options, we've actually identified a place in Surry Downs that I'm hoping might work long-term but it is literally a shell of a building and I'm told that it could be 12 months ... before that's ready to be used in office ... I'm really hoping that I'm not going to be told that I have to stay in a temporary office in Virginia for 12 months, I hope that they can find me something ... I'm using a motorhome, I'm not fussy about what I get as an office ... I'd like to be in the seat where the residents and I represent live ... (Schiller: you've accused Rob Lucas, the Treasurer, of an act of political bastardry that's strong words, why would you use that term and why do you think Rob Lucas is responsible?) Well the decision not to allow me to have an office at The Village was the Treasurer's, he confirmed that, that was his decision ... this rule that he seems to be enforcing which is your office absolutely, 100% must be within the boundaries of your seat appears to me only to be a rule Mr Lucas says we need to follow. I know that the residents in the Seat of Wright don't mind if the office for their MP is 370 metres out of the seat ... (Schiller: just hang on there a sec ...)

Rob Lucas, Treasurer (ABC RADIO ADELAIDE 17.40-17.46) Electorate boundaries redistribution: MP working out of motorhome / Claims of political bastardry

(Schiller: Rob Lucas joins me ... you've been accused of an act of political bastardry. It does seem a little bit sitcom that he's only 370 metres out of the electorate so you've relocated him. Talk us through the reasons for the decision ...) that's pretty simple ... most of your listeners will agree with the common-sense solution. The simple answer is if there's a Member of Parliament who's the Member for a particular electorate and there's only one electorate office, then that Member of Parliament has the right to be in that electorate office ... Mr Boyer's just conceded that the office is not in his electorate, it's actually in the electorate of Paula Luethen's and if he was to take that office ... she wouldn't have an office ... the simple answer is there's one electorate office in that particular electorate and the Member for that electorate has the first right to actually be in that office ... we've now established ... the former Government of which Mr Boyer was actually a ministerial staffer, they were told 12 months before the election that this was likely to occur, that is electorates like Mr Boyer's electorate of Wright didn't have an electorate office and what the former government should have done was to start the process 12 months ago of finding an electorate office ... it was Mr Boyer's government that ignored that advice and didn't do it ... Mr Boyer can actually go to see forme Treasurer, Mr Koutsantonis, and ask him the question as to why didn't he get off his backside and actually find an electorate office for him. (Schiller: ... Virginia is over 20ks from his electorate, couldn't you find an office closer, even a temporary one?) Well the answer to the question is we are [unclear] in Treasury working very hard to try and find not only for Mr Boyer but for another Member as well that doesn't have an electorate office

in their electorate, an electorate office to move into. In the interim the issue is are there any other vacant offices anywhere that they can move into ... so that their staff can move to ... are there any other vacant offices around that are close? And the answer is no. We actually would have to find new premises, lease it and make sure that it's suitable for Mr Boyer to move into. He knows that's the case, he's a former ministerial staffer so he's well versed in these sorts of things. (Schiller: What do you think of the motorhome option?) Well that's a decision for Mr Boyer ... it's really up to him. I assume as long as he declares that he's received a gift from somebody that's entirely his prerogative as to whether or not he takes a gift from somebody and utilises it ... in the interests of trying to find him an office, Treasury officers are working as hard as they can to try and identify an office ... their intentions are not to delay this for 12 months, they'll be working as hard as they can to find him an office in his electorate, not in somebody else's electorate, to move to ... his preferred option would be to kick out the Member for King from her electorate office so that she wouldn't have an office ... in her particular electorate ... most of your listeners would understand that wouldn't be very fair on the Member who the electorate office happens to be in ... Treasury worked very hard to find that ... the simple solution would have been the former Minister and the Treasurer had done what he was told to do or recommended to do and found an office before the election so that whoever was elected as the Member for Wright would have had an office in his or her electorate.

## Back to Blair Boyer

(Schiller: The Treasurer, Blair, has said that this was something that the previous government, your government failed to do and you're paying the price for their procrastination. Would you agree with that?) Well there was a couple of things there that Mr Lucas glossed over ... it's pretty gobsmacking to hear me being sent 25kms away to Virginia to a temporary office as the common-sense solution ... when I was told that I could move into the office at The Village I said that 'That's great and I commit to staying in this office as long as I am the Member for Wright.' Now my understanding, and I've been told this by the Member for King, is that not only did she not originally want to have her office at The Village but even now that the Treasurer has moved her in there she's already looking for other properties so she can move out ... that's going to result in whenever she finds something that's more to her liking that office, which has been an electorate office for 20 years, will be empty and the taxpayer will pay to find and fit out offices for both the Member for Wright and the Member for King.

### **Back to Rob Lucas**

(Schiller: Let's finally go to the Treasurer, Rob Lucas ... is that true that your Member's planning to move out of that office? It sounds like a game of musical chairs with public money, Treasurer.) Mr Blair firstly refused to answer your question because he knows he can't ... it was his government's fault that he's in the problem that he's in, he didn't answer that question. And no, his claims in relation to the Member for King moving out of that particular office, there's a lease on that ... well into next year and at the very least the Member for King will have to stay in that office whilst that lease is there and maybe for even longer. It's not the decision for the Member for King as to which particular electorate the Member for King or indeed Mr Boyer moves to, it's a decision for me, as Treasurer, and I've made the decision that the Member for King should be in the electorate office which is within her electorate and I've made the decision that Mr Boyer should be in an electorate office in his own electorate, not in somebody else's electorate ... Mr Boyer just refuses to answer the questions it's his own government's fault that he's in the position he's in.



### Key Points:

- On the 7 May 2018 a status update was provided to you detailing activity relating to relocations and works for Electorate Offices. Attached is the most recent table and some additional detail regarding Wright, Hurtle Vale and Elder Electorate Offices.
- Wright Electorate Office Surrey Downs site is no longer a viable relocation option. Negotiations with the Lessor of the Manor Farm Shopping Centre, 53 Northbri Avenue, Salisbury East are well advanced regarding a site of either 100 square metres or 140 square metres in size. Options for a short term lease arrangement (1 year plus 1 year option) to establish a temporary Electorate Office and a longer term lease arrangement (4 year plus 4 year option) are being investigated with the Lessor with a meeting scheduled for 25 June 2018.
- The Member continues to utilise a loaned 'Winnebago' van as a mobile Electorate Office in addition to the fully functional Electorate Office provided for him at Virginia. (former Taylor EO). Concerns regarding work, health and safety (and security) of staff, constituents and the Member himself have been discussed with the Member and WHS policies reinforced with staff.

### **Key Points:**

- The temporary relocation of the Member for Wright, Mr Blair Boyer MP to the former Taylor Electorate Office premises in Virginia took place on 11 April 2018.
- The Member for Wright wrote to you on 16 May 2018 requesting assistance by way of additional resources to maintain communication / services to his constituents whilst he is located temporarily in the former Taylor Electorate Office at Virginia.
- The actual cost of the Australia Post mail out already undertaken, the cost of Post Office box mail forwarding, costs of portable signage and the cost of Facebook push marketing has been requested several times from Mr Boyer since 24 May 2018 with no response to date. In the absence of this information, the reasonable costs approved for the Member for Hurtle Vale have been used as an indicator of reasonable costs.
- Mr Boyer has requested full reimbursement of his Global Allowance for the cost associated with an electorate wide addressed letter distributed via Australia Post advising his constituency of the temporary office located at Virginia (see copy attached). Electorate Services do not support this request, as a non-addressed walk out delivery information flyer to each household is considered a far more cost effective method of delivery. The budget afforded to the Member for Hurtle Vale for this same activity of a similar size was a one off cost of \$3,200.
- Mr Boyer has also sought pre-approval of budget for a further mail out when a new
  permanent electorate office is established within the new electorate of Wright. (estimated
  cost in excess of \$15,000) The Global Allowance is provided for and utilised by all new
  Members to establish themselves in their new electorate and Mr Boyer's situation is not
  materially different. Electorate Services do not support this request.
- Mr Boyer has requested that the costs of forwarding Australia Post mail to Virginia from Golden Grove be covered. The budget afforded to the Member for Hurtle Vale for this same activity was a one off cost of \$950 for one year. Electorate Services considers this to be a reasonable cost.
- Mr Boyer has been supported in his move to Virginia and has unpacked into the temporary office over the last 5–6 weeks. Electorate Services does not consider any additional resources are required to move into the Virginia office. Mr Boyer has requested casual staffing for 5 full days to support the move to the new electorate office

once established in the electorate of Wright. This request for additional resources is considered reasonable for use at a later time.

- Mr Boyer has requested that a sponsored Facebook advertisement informing constituents of the mobile office hours be approved. The budget afforded to the Member for Hurtle Vale for this same activity was a 'lifetime spend' of \$900 over a 9 month period. Electorate Services agrees that this is a cost effective method of communication.
- Temporary signage used by Members operating outside their permanent electorate office location has previously been paid for by Members from their Global Allowance allocation (eg. for use at street corner meetings, stands / listening posts in shopping centres etc.). Electorate Services recommends the costs Mr Boyer claims, currently unquantified, to have incurred from the private sourcing of these signs can reasonably be reimbursed consistently with the Global Allowance Guidance Notes.

Thank you for giving me the honour of representing you in State Parliament. Over the election campaign, I knocked on over 11,000 doors and spoke to thousands of residents. As I said during the campaign, I will be a Member of Parliament who comes to you.

Over the coming months I will hold Street Corner Meetings in every suburb of the electorate. I will also endeavour to knock on the doors of all 13,500 homes over the next four years.

In the meantime, my priority is setting up an office so you will have a place you can drop in and seek assistance, or have a chat with me. I am trying to find a location that is accessible to everyone. Once finalised, I will advise you of that location.
