APPLICATION UNDER THE FREEDOM OF INFORMATION ACT 1991

I refer to your application made under the *Freedom of Information Act* 1991 (FOI Act), received in this office on 3 December 2018.

Your application seeks access to:

"All files, reports, documents, notes, briefings and emails detailing the cost of indoor plants in the Treasurer's Ministerial office for the period 18 March 2017 – 17 March 2018 and 18 March 2018 to date."

The purpose of this letter is to advise you of my determination. An extensive search was conducted within this office. I wish to advise that two documents have been identified within scope of your request for the period 18 March to date. I have considered the documents and determined to release them in full.

Based on the information in the attached reports, no change has been made to plant hire arrangements and supplier (Jarrett Indoor Plant Hire) which were in place on 18 March 2018. The cost of plant hire has not altered and the quantity of plants is unchanged.

My office does not hold records prior to 17 March 2018.

No fees and charges are payable for this application.
