### Freedom of Information – Unclaimed money records

I refer to your application under the *Freedom of Information Act 1991* (FOI Act), received by the Department of Treasury and Finance (DTF) on 15 July 2020.

Your application specifically requested:

*'A copy of ALL unclaimed money records held by the South Australian Government Treasury.'*

You subsequently amended the scope to:

*'A copy of unclaimed monies records held by South Australian Government Treasury for amounts over \$50.00.'*

The purpose of this letter is to advise you of my determination.

### Appeal Rights

- be lodged at an office of DTF, or emailed to [freedomofinformation2@sa.gov.au](mailto:freedomofinformation2@sa.gov.au) within 30 days after the day on which you receive this letter or within such further time as the principal officer may allow.
