## APPLICATION UNDER THE FREEDOM OF INFORMATION ACT 1991

I refer to your application made under the *Freedom of Information Act 1991* (the Act), dated 12 November 2019.

Your application seeks access to:

"All minutes, briefings and correspondence titled 'Industry Advocate – Meeting with Intract Indigenous Contractors and McMahon Services" as described on the Objective document management system, between 23 February 2019 and 12 November 2019."



- On Friday 3 May 2019, Mr Steven Kochergen, Manager- Infrastructure and Transport, McMahon Services and Mr John Briggs, General Manager and Aboriginal majority owner of Intract Indigenous Contractors met with Ian Nightingale, the Industry Advocate, Sue Panagaris from the Office of the Industry Advocate (OIA) and Ms Khatija Thomas, Director, Aboriginal Engagement, Department for Planning, Transport and Infrastructure (DPTI).
- A number of matters were identified which would assist Intract Indigenous Contractors to be in a better position to successfully tender for State Government funded projects.

#### **PURPOSE**

 To provide you with an overview of my meeting on Friday 3 May 2019 with Steven Kochergen, Manager- Infrastructure and Transport, McMahon Services, and Mr John Briggs, General Manager, Intract Indigenous Contractors and the resulting actions.

#### BACKGROUND

- On 2 April 2019, you met with Steven Kochergen and John Briggs to discuss increasing Aboriginal participation in State Government funded contracts. After this meeting you requested that Mr Biggs and Mr Kochergen meet with the Industry Advocate to further this discussion.
- A follow-up meeting was held on Friday 3 May 2019 where both parties raised their concerns about their inability to secure State Government infrastructure contracts and this was followed by a discussion about the support available from the State government.
- An invitation to attend this meeting was accepted by Khatija Thomas, Director, Aboriginal Engagement, DPTI. In this role, Ms Thomas is responsible for increasing the Aboriginal supply chain and workforce content of infrastructure projects delivered by DPTI in South Australia.
- Mr Briggs informed the meeting Intract Indigenous Contractors does not tender directly for State Government funded infrastructure projects because their cost structures make them uncompetitive against non-Aboriginal businesses due to the additional costs associated with training and mentoring Aboriginal employees.
- Mr Briggs wanted to see South Australian procurement policy changed in line with the Federal Government where a limited tender approach is used in remote and regional areas for Aboriginal businesses only. This quarantine of funding approach to procurement is not included in the Aboriginal Economic Participation Policy however the use of a Tailored Industry Participation Plan with increased weighting used by Agencies can achieve favourable outcomes for local Aboriginal enterprise.
- Ms Thomas committed to investigate opportunities for Intract Indigenous Contractors, along with other South Australian Aboriginal businesses, for future projects but it will require they tender for contracts above \$220,000. There may be opportunities as sub-contractors for large projects such as the \$200 million Joy Baluch AM Bridge Duplication project in Pt Augusta.

# **KEY POINTS**

 Opportunities have been provided to Mr Briggs to promote his business to decision makers and procurement staff across government and the private sector through Aboriginal Meet the buyer events, the Aboriginal Business Expo; the Adelaide Indigenous Trade Fair 2018; General Meet the Buyer event plus Supplying to Government workshops. Such opportunities will continue to be provided to Intract Indigenous Contractors and all other South Australian owned Aboriginal businesses with another Indigenous Trade Fair scheduled for Adelaide in August 2019.

- The Industry Participation Consultant Aboriginal Business also works closely with Mr Briggs, providing one on one consulting as required and forwarding relevant tenders as they are released by State Government Agencies.
- Ms Khatija Thomas, Director of Aboriginal Engagement, DPTI will be sourcing increased opportunities for Intract Indigenous Contractors and other South Australian Aboriginal businesses to participate in the supply chain of major projects delivered by DPTI in this State.
- Intract Indigenous Services is a Supply Nation certified business and included on the South Australian Government owned, and Supply Nation administered, online Aboriginal Business Directory - Aboriginal Business Connect.
- Responsible Government Agencies (RGAs) have set targets for Aboriginal Procurement as a percentage of their total expenditure and the OIA will work closely with procurement staff and Tier 1 contractors to ensure these targets are met. There will be an increased focus on opportunities for Aboriginal businesses to quote and tender for State Government contracts, including direct negotiation for contracts valued under \$220,000.
- The OIA is delivering two of the Premier's Priority Projects through the South Australian Aboriginal Action Plan 2018- 2020 and will continue to provide support and advocate for all eligible South Australian Aboriginal owned businesses providing economic benefit to Aboriginal South Australians.

### CONCLUSION

Mr Briggs accepts strategies are needed to lower operating costs for Intract Indigenous Contractors. OIA has already contacted Indigenous Business Australia (IBA) to discuss the opportunity for Intract Indigenous Contractors and IBA to co-fund a business consultant to work with Mr Briggs to assist in this process.
