

TREASURER'S REPRESENTATIVE REPORT SA WATER BOARD MEETING 26 March 2020 (Board meeting 287)

FINANCIAL PERFORMANCE

 SA Water's estimated full year profit is forecast to be on budget. Higher than budgeted sales, and lower than budgeted expenditure, are expected to be offset, in full, by revenue adjustments arising from the conclusion of the current regulatory period on 30 June 2020.

SIGNIFICANT ITEMS

COVID-19

- o SA Water has enacted business plans to ensure the continuity of water and wastewater services.
- SA Water do not forecast any significant decline in water sales as customers move from commercial and non-residential use to residential use.

OTHER MATTERS

Adelaide desalination plant (ADP)

- o The ADP has produced 18.8 ML of water to 29 February 2020 to support the Water for Fodder program. Production averages 180 ML per day (60% of full capacity). Production at this level will continue throughout most of March and April, with the target of 40 GL on track to be delivered by mid-June.
- o The marginal cost of producing the 40 GLs from the ADP in 2019-20 is estimated at approximately \$32.5m. Up to a further 60 GL will be produced in 2020-21 at a cost of up to \$49.6 million.
- SA Water is anticipating full cost recovery of expenditure in accordance with the agreement reached between the Commonwealth and the State that no profit should be made from the costs of producing water from the ADP.
- The Minister for Environment and Water will shortly request that ESCOSA commence a review of the actual costs of production.

Reservoirs

- o Mt Bold is to be emptied by mid-May for three weeks for capital works on the lower gates in the inlet structure, after which it will be refilled from the River Murray to typical late autumn levels.
- o For approximately four weeks in May and late June, the ADP will be the primary source of water for the southern metropolitan Adelaide area. Management confirmed that these arrangements will not affect the ADP water production arrangements with the Commonwealth under the Water from Fodder program.

Metropolitan service delivery

 Costs for the Metro Alliance contract continue to be over budget with work volumes significantly above the three year average. A number of operational improvements continue to be pursued within Allwater to

reduce the outstanding backlog to a reasonable level. Management is forecasting a \$5.5 million overrun at year end, including a \$2 million recovery from the Alliance partners.

Adelaide Service Delivery Project

As part of the procurement process for the Adelaide Service Delivery Project, SA Water continues to run workshops with short-listed tenderers for the delivery of future production and treatment services and field services from 1 July 2021. The tender period closes on 15 April 2020 with evaluation outcomes to be presented to the Minister around July 2020. Final approval of successful tenderers is expected in late October 2020.

Development Contribution Framework

- o In response to concerns by ESCOSA and the development industry, SA Water is to investigate the implementation of a cost sharing mechanism to address the potential disadvantage to "first mover" developers.
- Currently where a developer requires an extension or upsizing of water, wastewater or recycled water infrastructure to facilitate their development, SA Water requires the first developer to fully fund the works. Industry is concerned that these works potentially benefit other future developers who follow and only pay to connect, with no contribution being required towards the cost of the upgraded infrastructure.
- SA Water currently has no mechanism available to ensure future beneficiaries pay their share of these infrastructure works.
- A proposal will be developed for the consideration of the Board by June 2020. The proposal will be informed by a model used by SA Power Networks which requires beneficiaries to pay for the infrastructure.

Eyre Peninsula Desalination Plant

- The proposed completion date for the Eyre Peninsula Desalination Plant has shifted from December 2020 to September 2021 due to delays in selecting the location of the seawater intake and outfall structures at Sleaford Bay which would be supported by the local Barngala and Nauo Aboriginal communities.
- o DEW is currently monitoring groundwater basins in the area and will advise SA Water on what that will mean for the status of groundwater allocations for the next financial year.
