APPLICATION UNDER THE FREEDOM OF INFORMATION ACT 1991

I refer to your application made under the *Freedom of Information Act 1991* (the Act), dated 5 August 2020.

Your application seeks access to:

"All minutes, briefings and correspondence titled 'Variation to Casino Duty Agreement for Temporary Casino Duty Deferral' as described on the Objective document management system, between 9 April and 5 August 2020."

The prescribed legislative timeframe to determine this application has expired and is now deemed as refused access to documents relevant to your application. I refer to my letter dated 18 August 2020 where I sought additional time to make my determination.

The purpose of this letter is to advise you of my determination. An extensive search was conducted within this office. A total of 4 documents were identified as answering the terms of your application.

I grant you access in full to 2 documents; copies of which are enclosed. I grant you access in part to 1 document; a copy of which is enclosed. I refuse you access in full to 1 document.

Document 1 is released in part as it contains legal advice subject to legal professional privilege. This advice is redacted pursuant to clause 10(1).

Documents Refused in Full

Document 3 is a copy of the Casino Duty Agreement between the Treasurer and SkyCity Adelaide. This agreement was tabled in Parliament on 21 July 2020 and is publicly available.

Exemptions

I refer to my correspondence of 1 April 2020, advising that the Government had approved a temporary six-month deferral of casino duty payable by the Adelaide Casino for payments due from April 2020 (based on March activity).

The correspondence noted that officials were working though the detail of how the deferral would apply.

I am advised that a variation to the Casino Duty Agreement in writing, pursuant to clause 13.3 of the agreement, is the preferred option for implementing the temporary six-month deferral of Casino Duty.

Please find attached a variation to the Casino Duty Agreement in duplicate for your signature.

I have already signed both copies on behalf of the Government,

Each page of the agreement should be initialled.

The variation agreement allows for a temporary six month deferral of monthly casino duty payments for the months of March to August 2020 inclusive, due on 7 October 2020.

I ask that the duplicate copies of the variation agreement are signed on behalf of Skycity Adelaide Pty Ltd and returned to my office.

After the documents are returned I will arrange to have copies of the variation laid before both Houses of Parliament within 12 sitting days as required under section 18(2) of the Casino Act 1997.



Key points:

On 1 April 2020 you advised the Adelaide Casino that the South Australian Government
had approved a temporary six-month deferral of casino duty payable by the Adelaide
Casino during from April 2020 as a result of the Covid-19 restrictions (<u>Attachment 3</u>), You
also advised that officials would work through the detail of how the deferral would be
implemented.



- Crown Law advice was sought
- Casino duty must be paid "in accordance with the casino duty agreement" under section 51(1) of the *Casino Act 1997*. Clause 6 of the Casino Duty Agreement provides for monthly payments of the duty.
- Crown Law advised
- Crown Law has drafted a variation to the Casino Duty Agreement ready for signature by all parties.
- The draft agreement allows for a six month deferral of monthly casino duty payments for the months of March (normally payable in April) to August 2020 inclusive until 7 October 2020.
- Two copies of the variation agreement are required to be signed to ensure that the licensee has an original copy of the variation after it has been tabled in Parliament.
- A draft letter to Mr David Christian, General Manager of the Adelaide Casino is also attached enclosing copies of the agreement for signature by Skycity Adelaide (Attachment 2).
- Once the signed variation has been returned from the Adelaide Casino in duplicate it will be required to be laid before both Houses of Parliament within 12 sitting days.
