#### Freedom of Information - Reimbursements

I refer to your application under the *Freedom of Information Act 1991* (FOI Act), received by the Department of Treasury and Finance (DTF) on 17 August 2020.

Your application specifically requested:

'Copies of all financial, bank and credit card statements, briefings, minutes, reports, emails, letters, meeting agendas diary entries etc for reimbursements paid to the Minister and staff from 2016-2018'

Under the Act, an agency has 30 days to respond to a freedom of information request. As DTF did not respond to your request within the time frame required, the department is deemed to have refused you access to all documents relevant to your application. However, I have determined to process the request as if the statutory time frame had been met.

The purpose of this letter is to advise you of my determination.

A total of 98 documents were identified as answering the terms of your application and I have determined as follows:

- I grant you access in full to 19 documents, copies of which are enclosed, and
- I grant you access in part to 79 documents, copies of which are enclosed.

Please refer to the attached schedule that describes each document and sets out my determination and reasons in summary form.

### Documents released in full

Documents 17-18, 20, 22, 28, 30, 40, 52-57, 87-88 and 95-98

### Documents released in part

Documents 1-5, 7-10, 12-15, 23-27, 29, 31-39, 41-45, 47-51, 58-67, 69-86 and 89-94.

These documents contain information relating to the personal affairs of third parties. Under clause 6(1) of Schedule 1 to the Act, a document is exempt if its disclosure would involve the 'unreasonable disclosure of information concerning the personal affairs of any person'. This information falls within the definition of personal affairs under the Act and is therefore exempt from release pursuant to clause 6(1).

Documents 1-3, 5-6, 11, 16, 19, 21, 24, 27, 35, 46, 68, 73, 79 and 90

The above documents contain account numbers which form part of the business and financial affairs of the government of South Australia. These account numbers are still active. If released there is a possibility some adverse effect could flow from their disclosure. DTF considers that, on balance, it would be contrary to the public interest to release it. In light of this, DTF submits that the information is exempt pursuant to clause 7(1)(c) of Schedule 1 to the FOI Act.

### **Exemptions**

Please note, in compliance with Premier and Cabinet Circular PC045 - *Disclosure Logs for Non-Personal Information Released through Freedom of Information* (PC045), DTF is now required to publish a log of all non-personal information released under the *Freedom of Information Act 1991*.

### **Appeal Rights**

If you are aggrieved with this determination, you have a right to apply for internal review under subsection 29(1) of the FOI Act. Pursuant to subsection 29(2), your application must:

- be lodged at an office of DTF, or emailed to <a href="maileographe-freedom-finformation2@sa.gov.au">freedom-finformation2@sa.gov.au</a> within 30 days after the day on which you receive this letter or within such further time as the principal officer may allow.
