 - o River Murray Flood Essential Services Reconnection Grant
 - o River Murray Flood Re-establishment Grant.'

As DTF did not respond to your request within the time frame required, the department is deemed to have refused you access to all documents relevant to your application. However, I have determined to process the request as if the statutory time frame had been met.

The purpose of this letter is to advise you of my determination.

Pursuant to Part 1, Section 4(4) and (5)(b) of the FOI Act, as DTF was able to produce the requested document due to the nature of the information readily held by the data management system, the document created is to be considered as a document held by the agency.
