### Freedom of Information – Global Transfer

I refer to your application under the *Freedom of Information Act 1991* (FOI Act), received by the Department of Treasury and Finance (DTF) on 18 April 2023.

Your application specifically requested:

*“Global transfers between electorate offices approved by the Treasurer including the following information: For each Electorate office where a global transfer was initiated, the recipient of the global transfer, the value of the global transfer and the date of the global transfer”. Date Range: 21/03/2022 to 18/04/2023.*

Under the Act, an agency has 30 days to respond to a freedom of information request. As DTF did not respond to your request within the time frame required, the department is deemed to have refused you access to all documents relevant to your application. However, I have determined to process the request as if the statutory time frame had been met.

The purpose of this letter is to advise you of my determination.

One document was identified as answering the terms of your application and I have determined to grant you access in full to this document, a copy of which is enclosed.

Please note, in compliance with Premier and Cabinet Circular PC045 - *Disclosure Logs for Non-Personal Information Released through Freedom of Information* (PC045), DTF is required to publish a log of all non-personal information released under the *Freedom of Information Act 1991*.

## Appeal Rights
