## Freedom of Information Internal Review - Adelaide Oval Hotel Proposal

I refer to your Freedom of Information application received by the Department of Treasury and Finance on 3 December 2018 and your Internal Review application received on 17 January 2019.

Your applications specifically requested:
"All minutes, briefings, notes, emails and correspondence from the South Australian Government Financing Authority to the Department of Treasury and Finance regarding the proposed hotel development at Adelaide Oval"

## Determination under review

DTF did not make a determination on your initial application within the 30-day time period required by the Freedom of Information Act 1991 (the Act). Accordingly, DTF was deemed to have refused access in full to all documents relevant to your application.

## Outcome of internal review

A total of 31 documents were identified as answering the terms of your application and I have determined as follows:

- I grant you access in full to 3 documents, copies of which are enclosed
- I grant you access in part to 8 documents, copies of which are enclosed, and
- I refuse you access to 20 documents.

Please refer to the attached schedule that describes each document and sets out my determination and reasons in summary form.

This document is a Costing Comment specifically prepared for attachment to a Cabinet Submission and is therefore exempt pursuant to clause 1(1)(a) of Schedule 1 of the FOI Act.

## Documents 13 and 15

These documents are draft Cabinet submissions. I have therefore determined to refuse access to these documents in full pursuant to clause 1(1)(b) of Schedule 1 of the FOI Act.

Documents $3-12,17,21,23,25,27$ and 29
These documents contain information which, if released, would disclose details concerning a deliberation or decision of Cabinet and are therefore exempt pursuant to clause 1(1)(e) of Schedule 1 of the FOI Act.

## Documents 3 and 30

Under clause 10(1) of Schedule 1 to the FOI Act, information is exempt from disclosure if it would be privileged from production on the ground of legal professional privilege. These documents contain legal advice provided to the government by its legal advisor, the Crown Solicitor, information which is subject to legal professional privilege. I have therefore determined to exempt these documents pursuant to clause 10(1).

(3) In this clause, a reference to Cabinet includes a reference to a committee of Cabinet and to a subcommittee of a committee of Cabinet.

## Clause 10 - Legal Professional Privilege

(1) A document is an exempt document if it contains matter that would be privileged from production in legal proceedings on the ground of legal professional privilege.
