APPLICATION UNDER THE FREEDOM OF INFORMATION ACT 1991

I refer to your application made under the *Freedom of Information Act 1991* (FOI Act), dated 26 July 2019.

Your application seeks access to:

"All minutes, briefings and correspondence titled 'Transfer of Domiciliary Equipment Services to Non-Government Sector-Market Sounding Completion' as described on the Objective document management system, between 12 July 2018 and 7 May 2019"

The purpose of this letter is to advise you of my determination. An extensive search was conducted within this office. One document was identified as answering the terms of your application.

I grant you access in part to 1 document, a copy of which is enclosed.

Released in part

Document 1 is a briefing prepared by DTF in relation to the Transfer of the Domiciliary Equipment Service to the Non-Government Sector.

The briefing contains information concerning a decision made in Cabinet and information which will be taken to Cabinet. I therefore determine this exempt under clause 1(1)(e) and (f) to the FOI Act.

Exemptions

Clause 1 - Cabinet Documents

- (1) A document is an exempt document—
 - (e) if it contains matter the disclosure of which would disclose information concerning any deliberation or decision of Cabinet.
 - (f) if it is a briefing paper specifically prepared for the use of a Minister in relation to a matter submitted, or proposed to be submitted to Cabinet.



Key Points:

DES manages the equipment and home modification needs of approximately 15,000 people in South Australia. This includes clients from the National Disability Insurance Scheme (NDIS), South Australian Department of Human Services (DHS), a range of

hospitals and community care agencies, and people privately hiring equipment.

Since late-2018, the Commercial and Economics Branch (CEB) has been working
collaboratively with the Department of Human Services (DHS) to prepare for the market
process to transfer DES to the NGS. Market sounding is now complete, marking an
important milestone in confirming the strategy for market engagement in 2019.



- The purpose of market sounding has been to:
 - Test the market appetite for the DES business;
 - Identify a potential bidder field and their general information requirements in a market process; and,
 - Confirm the appropriateness of the proposed two-stage market process of a public call for Expressions of Interest (EOI) followed by a Request for Tender (RFT) from shortlisted respondents.
- Market sounding has revealed that there is strong market interest in acquiring all or part
 of DES across both the not-for profit and commercial sectors, and across both existing
 market participants and organisations seeking to expand their offerings. A total of 15
 organisations attended Industry Briefing Sessions conducted as part of the Market
 Sounding, and 11 of those organisations subsequently responded to a Request for
 Information (RFI).
- The RFI sought feedback on a variety of aspects of the proposed transfer including;
 - The government's objectives for the transfer;
 - Willingness to take on DES employees;
 - Appetite to acquire DES assets; and
 - Service continuity for regional customers.
- The variety of respondents to the Market Sounding RFI confirm that the two-staged approach of EOI followed by RFT is appropriate. A public call for Expressions of Interest will maximise the opportunity for a diverse range of organisations to participate in the process, increasing the likelihood that an optimal transfer arrangement can be identified. A subsequent RFT process will allow for those organisations shortlisted from the EOI process to undertake detailed due diligence prior to submitting binding bids.
- The EOI is scheduled to be released publically via the SA Tenders and Contracts website on 8 March 2019.

It is anticipated that DHS will return to Cabinet for a decision
