# APPLICATION UNDER THE FREEDOM OF INFORMATION ACT 1991

I refer to your application made under the Freedom of Information Act 1991 (FOI Act), dated 1 October 2019.

Your original application sought access to:

"All correspondence (including but not limited to emails, letters, memos, reports, instant messages) between the Treasurer or any ministerial staff in the Treasurer's office, and the Minister for Health and Wellbeing or any ministerial staff in the Minister's office (between 1 July 2018 and 1 October 2019), related to the health budget or health expenditure."

The application was then amended to:

"All correspondence (including but not limited to emails, letters, memos, reports, instant messages) between the Treasurer or any ministerial staff in the Treasurer's office, and the Minister for Health and Wellbeing or any ministerial staff in the Minister's office (between 1 July 2018 and 1 October 2019), related to the health budget or health expenditure in respect to ramping, KordaMentha, CALHN or mental health."

The purpose of this letter is to advise you of my determination. An extensive search was conducted within this office. 10 documents were identified as answering the terms of your application.

I grant you access in full to 2 documents; copies of which are enclosed. I grant you access in part to 8 documents, copies of which are enclosed.

Documents 1, 2, 5, 6, 7 are all released in part as the attachments referenced in the emails were all prepared for Cabinet. I therefore determine this exempt pursuant to clause 1(1)(a) to the FOI Act.

Document 3 is released in part with out of scope information removed.

Document 4 is released in part as the attachment is a budget bid which was prepared for use by the Minister for a matter to be submitted to Cabinet.

Document 8 is released in part as both attachments referred to in the briefing are internal working documents. These are working documents which were superseded by the subsequent work of KordaMentha and subsequent documents released by KordaMentha (CALHN Diagnostic Review September 2018 and CALHN Operational Financial Recovery Plan November 2018). Disclosure of these draft documents has the potential to mislead and distract the public in relation to matters that have subsequently been more fully explored, analysed and disclosed.

I therefore determine this information exempt pursuant to clause 9(1)(a)(i) and 9(1)(a)(ii).

# **Exemptions**

### Clause 1 - Cabinet Documents

- (1) A document is an exempt document—
  - (a) if it is a document that has been specifically prepared for submission to Cabinet (whether or not it has been so submitted); or
  - (b) if it is a preliminary draft of a document referred to in paragraph (a); or
  - (c) if it is a document that is a copy of or part of, or contains an extract from, a document referred to in paragraph (a) or (b).
  - (e) if it contains matter the disclosure of which would disclose information concerning any deliberation or decision of Cabinet; or
  - (f) if it is a briefing paper specifically prepared for the use of a Minister in relation to a matter submitted, or proposed to be submitted to Cabinet.

# Clause 9 — Internal Working Documents

- (1) a document is an exempt document if it contains matter—
  - (a) that relates to—
    - (i) any opinion, advice or recommendation that has been obtained, prepared or recorded; or
    - (ii) any consultation or deliberation that has taken place,

in the course of, or for the purpose of, the decision-making functions of the Government, a Minister or an agency; and

(b) the disclosure of which would, on balance, be contrary to the public interest.

Alternatively, you can apply to the South Australian Civil and Administrative Tribunal. If you wish to seek a review, Section 39(3) of the Act states you must do so within 30 calendar days of receiving the determination.

We are workers in the community mental health sector. We work as community support workers in the IPRSS and GP Access Programs of Uniting SA. Every day we work with people in the community who are in mental distress to support them to stay well.

We are concerned by your government's plan to cut 25% of funding from community mental health services. This will have a huge impact on the people who need our programs, on maintaining a well-qualified and experienced workforce, and on the State's health system including hospitals.

Across South Australia, mental health programs are full with waiting lists, and there is an ongoing need to make spaces available in our programs. While some participants are transitioning to the NDIS, cutting mental health funding will prevent us from providing support to community members currently on waiting lists across the state.

We urge you to reconsider these cuts and to invest in our community's mental health.





Dear Hon R I Lucas,

As the Mental Health Coalition of SA we are the peak body for the non-government mental health sector.

Our vision is that all South Australians affected by mental illness are receiving the support they need to live well in the community.

Some of our recent work has highlighted a 25 per cent (\$6.8m) funding reduction to State funded NGO mental health programs with the money being transferred to the Commonwealth NDIS program.

This work has been met with claims that this is a scare campaign impacting on the most vulnerable.

As the peak body whose core work is to highlight the needs of the most vulnerable in our community, we take these claims very seriously.

All of our messaging has been based on facts. These are the facts as we have heard from the SA Government and our membership:

## **FACTS**

The decision to transfer the \$6.8m from State funded mental health services to the Commonwealth was done several years ago by the previous government. This 'deal' has been inherited by Minister Wade.



MHCSA welcomes commitments made by Minister Wade that during the transition to NDIS no current service recipient will lose access to service. We have promoted this commitment as part of our messaging.

Mental health presentations to Emergency Departments are increasing at 5% per annum. Independent evaluations show the main service types experiencing these cuts are effective in supporting people to reduce their use of emergency and crisis services.

There is a high level of unmet demand already for these NGO mental health services. For example our members have told us;

- Diamond House "We are noticing an increase in people, especially those who have been deemed ineligible for NDIS funding...Some have been asked to find other service providers because they can no longer access the programs that they had been attending unless they have NDIS packages."
- **GROW** "...numbers appear to be increasing. We are contracted to see 400 individuals. We will exceed that figure this year and we predict it will rise again as most people accessing our service are not NDIS eligible. We have a range of attendees working (38%) who maintain their employment by attending their weekly support group."
- Housing And Support Programs (HASP) all of these programs are full.
  - Mind Australia Burnside HASP "Burnside HASP vacancies are highly sought after with an average of 10 referrals per vacancy."
- Individual Psychosocial Rehabilitation Support Services (PRSS) all of these programs but one (a rural and remote program) are full and have waiting lists.
  - Mind Australia "Southern Country and Central Country IPRSS vacancies are filled immediately; an average of 6 referrals are received per month."

We also know:

 Catherine House Recovery Accommodation Support Program (ASP) - "Our service supports women who have become homeless and have a mental illness from which they will recover. They will not be eligible for NDIS."

The NDIS is not designed to replace mental health services and will deliver different services and supports.

The 25% shift in funding will leave our state mental health system with less capacity to support vulnerable people who need these services into the future.



Affected service providers were surprised at the timing of this reduction in funding as they were previously assured by Departmental representatives that the funding reductions would not apply in the coming financial year.

It is not correct to say no South Australian will be impacted by this shift in funding. As you have just read there are many consumers and carers who will feel this.

When your constituents are contacting you about the reduction in NGO mental health services and raising their concerns we would appreciate you sharing these facts with them too as they are very likely to be the vulnerable who are being impacted.

1. Note that CALHN has not balanced its budget for a number of years and this year is projecting a \$270million deficit. This represents in excess of 10% of its budget.

2. Note that CALHN has developed a Sustainability Plan to drive financial recovery within the Network over the next three years.

3. Note that an internal Sustainability Steering Committee has been established to support the development and implementation of the plan.

4. Agree to a meeting with Raymond Spencer and Jenny Richter with Chris McGowan to discuss the Plan and the commitment required from Government for a successful implementation.

## **PURPOSE**

 To provide the Minister for Health and Wellbeing with information about the CALHN Sustainability Plan.

#### SUMMARY

- As previously noted, CALHN's projected end of year position for 2017-18 is estimated to be more than \$270 million in excess of its total operating budget of \$1.8 billion.
- After removing the impact of once off items, the annual deficit is estimated to be approximately \$200 million, which is unsustainable.
- CALHN has developed a Sustainability Plan (Attachment 1) to outline a consistent, focussed approach to a balanced budget by establishing a clear path to sustainability through achievable, phased priorities over the next three years.
- Specifically, the Sustainability Plan sets out in detail CALHN's financial position, the staff participation requirement to achieve the stated imperatives and the processes by which financial recovery can be achieved.
- The Plan is supported by the CALHN Strategic Directions Plan (Attachment 2) which provides more detail of the context of the current challenge facing CALHN, with direction for improved performance.
- The strategic imperatives within the Sustainability Plan focus on:
  - Capacity and Service Profile
  - Cultural Transformation
  - Workforce Planning and Capability.
- Programs aimed at financial sustainability and improving effectiveness, safety and
  quality underpin the Sustainability Plan. In some programs, outcomes will include a
  reduction in clinical, corporate and support staffing numbers due to the associated
  changes in activity. It is estimated that a reduction in approximately 1000 full time
  equivalent staff will be required as service profiles and delivery process are changed.
- Programs include :
  - Reduction in Length of Stay, enabling flexing-down of beds and decreasing of associated resources across CALHN sites.
  - Reduction in utilisation of guards / patient minding services,
  - Reduction in clinical staff agency expenditure and overtime,
  - Reduction in provision of specific clinical services, e.g. Sleep studies,
  - Reduction in the number of outpatients and outpatient clinics,
  - Transfer of appropriate activity to other Local Health Networks,
  - Cessation of the use of unconventional patient spaces within CALHN
  - Increase in site funding received from consistent, accurate coding practices,
  - Closure of St Margaret's hospital, and
  - Reinforcement of the Performance and Accountability Framework.
- Final scoping of these programs is currently underway, and a work schedule is being developed for each program. This will include expected savings and target dates.
- In the next two months, experts in business management, logistics and health informatics will be recruited. Whilst sustainability strategies are currently being implemented more focused work is expected to commence by August 2018.
- The Sustainability Steering Committee (SSC) will provide oversight and support for the Chief Executive Officer (CEO) and Chief Finance Officer (CFO) in directing and managing the plan. This committee is chaired by Raymond Spencer.
- However, this plan is not without its risks. The plan involves significant changes in the way in which medical staff provide these services. Previous savings plans have been unsuccessful partly because a small minority of CALHN medical staff have resisted any change and have expressed their concerns about change directly to former Ministers for Health or the former Premier.
- It is therefore requested that a meeting be arranged with the Minister to provide a detailed overview of the Sustainability Plan and its proposed outcomes. Following this, it is further proposed that meetings be arranged with the Premier and Treasurer to outline key aspects of the plan so that broader Government support is gained to fully implement the plan.

### BACKGROUND

- CALHN has not balanced is budget in many years and its overall service performance remains below its peers.
- CALHN has undertaken a series of workshops with key clinical and other leaders, external agencies and business and health experts to develop the Sustainability Plan.

# **COSTING COMMENT**

- The initial costs mainly includes the recruitment of experts in business management, logistics and health data analytics.
- These are intended as short term costs (up to 3 years) and will be offset in years 2 and 3 of the Plan by the savings made in the previous years.
- The Department of Treasury and Finance and the Department for Health and Wellbeing are aware that resources required to develop and implement the programs outlined in the Plan will create further cost pressures in year 1 of the plan.
