APPLICATION UNDER THE FREEDOM OF INFORMATION ACT 1991

I refer to your application made under the *Freedom of Information Act 1991* (FOI Act), dated 15 May 2019.

Your application seeks access to:

"All minutes, briefings and correspondence titled 'Social Impact Investment in South Australia' as described on the Objective document management system, between 12 July 2018 and 15 May 2019."

The legislative prescribed timeframe to determine this application has expired and is now deemed to have refused you access to all documents relevant to your application. I refer to my letter dated 26 May 2019 where I sought additional time to make my determination.

The purpose of this letter is to advise you of my determination. An extensive search was conducted within this office. A total of 2 documents were identified as answering the terms of your application.

I refuse you access in full to 1 document.
I grant you access in part to 1 document; a copy of which is enclosed.

Document Refused in Full

Document 1 is refused in full as it contains matter the disclosure of which would disclose information concerning a deliberation of a Cabinet committee. I therefore determine this information exempt pursuant to clause 1(1)(e) to the FOI Act.

Document Released in Part

Document 2 is released in part as it contains matter the disclosure of which would disclose information concerning a deliberation of a Cabinet committee. I therefore determine this information exempt pursuant to clause 1(1)(e) to the FOI Act.

The draft A3 'placemat' (Attachment 1 to Document 1) is refused in full as it was prepared for a Cabinet committee. I therefore determine this exempt pursuant to clause 1(1)(a).

Exemptions

Clause 1 - Cabinet Documents

- (1) A document is an exempt document—
 - (a) if it is a document that has been specifically prepared for submission to Cabinet (whether or not it has been so submitted); or
 - (b) if it is a preliminary draft of a document referred to in paragraph (a); or
 - (c) if it is a document that is a copy of or part of, or contains an extract from, a document referred to in paragraph (a) or (b).
 - (e) if it contains matter the disclosure of which would disclose information concerning any deliberation or decision of Cabinet; or
 - (f) if it is a briefing paper specifically prepared for the use of a Minister in relation to a matter submitted, or proposed to be submitted to Cabinet.

Please note, in compliance with Premier and Cabinet Circular PC045 - *Disclosure Logs* for Non-Personal Information Released through Freedom of Information (PC045), the Department of Treasury and Finance is now required to publish a log of all non-personal information released under the *Freedom of Information Act 1991*.

In accordance with this Circular, any non-personal information determined for release as part of this application, may be published on the DTF website. As I am determining this application as Principal Officer, Section 29(6) of the Act does not provide for an internal review. If you are dissatisfied with my determination you are entitled to exercise your rights of external review with the Ombudsman.

Alternatively, you can apply to the South Australian Civil and Administrative Tribunal. If you wish to seek a review, Section 39(3) of the Act states you must do so within 30 calendar days of receiving the determination.
