Freedom of Information – Office Manager for Office of the Treasurer credit card

I refer to your applications under the *Freedom of Information Act 1991* (FOI Act), received by the Department of Treasury and Finance (DTF) on 10 March 2020.

Your applications specifically requested:

T&F20/0142

'Copies of all invoices and receipts of charges against the Office Manager's credit card in the Office of the Treasurer From 15 March 2014 and 16 March 2018'

T&F20/0141

'Copies of all statements of the Office Manager's credit card in the Office of the Treasurer From 15 March 2014 to 16 March 2018'

Under the Act, an agency has 30 days to respond to a freedom of information request. As DTF did not respond to your request within the time frame required, the department is deemed to have refused you access to all documents relevant to your application. However, I have determined to process the request as if the statutory time frame had been met.

The purpose of this letter is to advise you of my determination.

A total of 64 documents were identified as answering the terms of your application and I have determined as follows:

- I grant you access in full to 3 documents, copies of which are enclosed, and
- I grant you access in part to 61 documents, copies of which are enclosed.

Please refer to the attached schedule that describes each document and sets out my determination and reasons in summary form.

Documents released in full

Documents released in part

Documents 1 – 44, 47 – 62, 64

These documents contain credit card and account numbers which form part of the business and financial affairs of the Government of South Australia. Some of these account numbers are still active. If released there is a possibility some adverse effect could flow from their disclosure. As the release of this information is not likely to enhance participation by members of the public in the democratic process, but could possibly have some adverse effect on the state's financial affairs, DTF considers that, on balance, it would be contrary to the public interest to release it. In light of this, DTF submits that the information is exempt pursuant to clause 7(1)(c) of Schedule 1 to the FOI Act.

These documents contain information relating to the personal affairs of third parties. Under clause 6(1) of Schedule 1 to the Act, a document is exempt if its disclosure would involve the 'unreasonable disclosure of information concerning the personal affairs of any person'. This information falls within the definition of personal affairs under the Act and is therefore exempt from release pursuant to clause 6(1).

Exemptions

Clause 6 – Documents affecting personal affairs

- (1) *A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead).*

Clause 7 – Documents affecting business affairs

- (1) *A document is an exempt document—*
- (c) if it contains matter—*
 - (i) consisting of information (other than trade secrets or information referred to in paragraph (b)) concerning the business, professional, commercial or financial affairs of any agency or any other person; and*
 - (ii) the disclosure of which—*
 - (A) could reasonably be expected to have an adverse effect on those affairs or to prejudice the future supply of such information to the Government or to an agency; and*
 - (B) would, on balance, be contrary to the public interest*

Please note, in compliance with Premier and Cabinet Circular PC045 - *Disclosure Logs for Non-Personal Information Released through Freedom of Information (PC045)*, DTF is now required to publish a log of all non-personal information released under the *Freedom of Information Act 1991*.

Appeal Rights

If you are aggrieved with this determination, you have a right to apply for internal review under subsection 29(1) of the FOI Act. Pursuant to subsection 29(2), your application must:

- be lodged at an office of DTF, or emailed to freedomofinformation2@sa.gov.au within 30 days after the day on which you receive this letter or within such further time as the principal officer may allow.
