APPLICATION UNDER THE *FREEDOM OF INFORMATION ACT 1991*

I refer to your application made under the *Freedom of Information Act 1991* (FOI Act), dated 12 November 2019.

Your application seeks access to:

"All minutes, briefings and correspondence titled 'RevenueSA – Land Tax Invoicing Schedule: Financial Year 2019-20' as described on the Objective document management system, between 23 February 2019 and 12 November 2019."

The legislative prescribed timeframe to determine this application has expired and is now deemed to have refused you access to all documents relevant to your application. I refer to my letter dated 19 November 2019 where I sought additional time to make my determination.

The purpose of this letter is to advise you of my determination. An extensive search was conducted within this office. A total of 1 document was identified as answering the terms of your application.

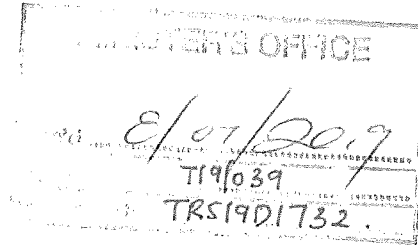

Key Points:


- The Land Tax Invoicing Schedule for the 2019–2020 financial year is not materially different to that used for the 2018–2019 financial year (Attachment A)
- Land tax billing will commence in October at the completion of ESL billing.
- Further invoicing and rebilling of ownerships will continue throughout the year as changes to property ownership details generate data updates from the Department of Planning, Transport and Infrastructure, councils and the public.
- Further invoicing and rebilling resulting from ownership issues will also occur where specific circumstances delay billing of individual accounts.


