### **Freedom of Information Internal Review — non-State Government Land tax payers**

I refer to your Freedom of Information application received by Department of Treasury and Finance on 11 October 2017 and your Internal Review application received on 22 November 2017.

Your applications specifically requested:

*'For 2016-17 please provide the number of non-state Government land tax payers whose aggregated taxable value is within each of provided bands [\$300,000 to \$599,999] and the amount of land tax revenue paid by taxpayers.'*

### **Determination under review**

DTF did not make a determination on your initial application within the 30-day time period required by the *Freedom of Information Act 1991* (the FOI Act). Accordingly, DTF was deemed to have refused access in full to all documents relevant to your application.

### **Outcome of internal review**

A total of 1 document was identified as answering the terms of the application and DTF has determined to release this document in full.
