APPLICATION UNDER THE FREEDOM OF INFORMATION ACT 1991

I refer to your application made under the *Freedom of Information Act 1991* (FOI Act), dated 12 December, 2018.

Your application seeks access to:

"All minutes, briefings, notes, documents, emails and correspondence held by the Treasurer, the Hon Rob Lucas and Treasurer's office in relation to the South Australian Productivity Commission between 26 July and 12 December 2018."

The purpose of this letter is to advise you of my determination. An extensive search was conducted within this office. Nine documents were identified as answering the terms of your application.

I grant you access to 1 document; a copy which is enclosed. I refuse you access to 8 documents.

Documents refused in full

Documents 2, 3 and 4 are submissions prepared for the consideration of Cabinet.

I therefore determine this information exempt, pursuant to clause 1(1)(a) to the FOI Act.

Document 5 is a briefing which was prepared for my use and which was a matter submitted to Cabinet for consideration.

I therefore determine this information exempt, pursuant to clause 1(1)(f) to the FOI Act.

Documents 6, 7 and 9 are copies of Hansard extracts, dated 2 August, 31 July and 20 June 2018, relating to the debate in both Houses of Parliament, on the South Australian Productivity Commission Bill 2018. These extracts are publicly available on the SA Parliament website.

Document 8 is a copy of an amendment which was to be moved by the Hon Frank Pangallo MLC to the South Australian Productivity Commission Bill 2018. This is publicly available on the SA Parliament website.

Exemptions
