Freedom of Information – Copies of Receipts – Under Treasurer

I refer to your application under the Freedom of Information Act 1991 (FOI Act), received by the Department of Treasury and Finance (DTF) on 12 September 2023.

Your application specifically requested:

'A copy of the receipt's for the Under Treasurer's transactions with Air B&B for the values of \$25 and \$410 dollars on 2 February 2023. The transactions were proactively disclosed via the Under Treasurer's government purchase card disclosure and appeared on the Under Treasurer's February 2023 statement.' [Date Range: 01/01/2023 – 28/02/2023]

The purpose of this letter is to advise you of my determination.

A total of 2 documents were identified as answering the terms of your application and I have determined as follows:

I grant you access in part to 2 documents, copies of which are enclosed.

Please refer to the attached schedule that describes each document and sets out my determination and reasons in summary form.

Documents released in part

Documents 1 and 2.

Contain credit card numbers that form part of the business and financial affairs of the Government of South Australia. These numbers are still active.

This information falls within the definition of business affairs under the FOI Act and disclosure of this information would, on balance, be of no benefit to the public. The information is therefore exempt from release pursuant to clause 7(1)(c) of Schedule 1.

Documents 1 and 2.

Names which can identify the owner of the property in connection with their private business, have been redacted.

This information falls within the definition of personal affairs under the FOI Act and is therefore exempt from release pursuant to Clause 6(1) of Schedule 1.

Exemptions

Clause 6—Documents affecting personal affairs

(1) A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead).

Clause 7—Documents affecting business affairs

- (1) A document is an exempt document—
 - (c) if it contains matter—
 - (i) consisting of information (other than trade secrets or information referred to in paragraph (b)) concerning the business, professional, commercial or financial affairs of any agency or any other person; and
 - (ii) the disclosure of which—
 - (A) could reasonably be expected to have an adverse effect on those affairs or to prejudice the future supply of such information to the Government or to an agency; and
 - (B) would, on balance, be contrary to the public interest.

Please note, in compliance with Premier and Cabinet Circular PC045 - *Disclosure Logs for Non-Personal Information Released through Freedom of Information* (PC045), DTF is required to publish a log of all non-personal information released under the *Freedom of Information Act 1991*.

Appeal rights

If you are aggrieved with this determination, you have a right to apply for internal review under subsection 29(1) of the FOI Act. Pursuant to subsection 29(2), your application must:

- · be addressed to the Principal Officer
- be mailed to GPO Box 1045, Adelaide SA 5001, or emailed to freedomofinformation2@sa.gov.au, within 30 days after the day on which you receive this letter or within such further time as the Principal Officer may allow.


