**Freedom of Information – Correspondence to Treasurer’s office regarding 2018/19
Federal Budget**

I refer to your application under the *Freedom of Information Act 1991* (FOI Act), received by the Department of Treasury and Finance (DTF) on 25 May 2018.

Your application specifically requested:

[Date range: 19/03/2018 to 24/05/2018] *All minutes, briefings, notes, emails and correspondence from the Department of Treasury and Finance to the Treasurer and the Treasurer's Office regarding the 2018 - 2019 Federal Budget*

The purpose of this letter is to advise you of my determination.

A total of 9 documents were identified as answering the terms of your application and I have determined as follows:

- I grant you access in full to 6 documents, copies of which are enclosed, and
- I refuse you access to 3 documents.

Please refer to the attached schedule that describes each document and sets out my determination and reasons in summary form.

These documents are briefing notes prepared specifically for use in Parliament, the disclosure of which would infringe the privilege of Parliament. I have therefore determined to exempt these documents in full pursuant to clause 17(c) of Schedule 1 to the FOI Act.

Document 7

This document consists of information from draft documents that were prepared specifically for submission to Cabinet. I have therefore exempted this document pursuant to clause 1(1)(c).

Exemptions

Clause 1 – Cabinet documents

(1) A document is an exempt document –

...
(c) if it is a document that is a copy of or part of, or contains an extract from, a document referred to in paragraph (a) or (b);

Clause 17 – Documents subject to contempt etc

A document is an exempt document if it contains matter the public disclosure of which would, but for any immunity of the Crown—

...
(c) infringe the privilege of Parliament

SCOPE

- **2018-19 Commonwealth Budget – Implications for South Australia**

MAIN SPEAKING POINTS

- The Federal Budget handed down last night will provide South Australians with \$10.8 billion in revenue next year.

Infrastructure Funding

- \$1.8 billion in funding is provided for critical road and rail infrastructure, secured by a Marshall Liberal Government through strong and productive advocacy, including:
 - \$1.4 billion for the North-South corridor
 - \$220 million for the Gawler Line electrification
 - \$160 million for the Joy Baluch Bridge.
- The additional funding of \$1.4 billion for the North-South Corridor brings the Commonwealth's total commitment for this project to \$3 billion.
- In total, the Commonwealth has committed \$5.2 billion to land transport infrastructure projects in South Australia.
- We will work with the Federal Government to deliver the best possible outcomes on the profile of infrastructure funding – finishing the work the former government failed to do to secure Commonwealth funding for these projects.

Defence

- New equity investments in naval infrastructure to grow the shipyards at Osborne, leverage the \$90 billion in defence spending, and create South Australian jobs.

Health

- In public hospital funding, South Australia is estimated to receive \$7.1 billion over the five years to 2021-22. The Budget also confirms the intended funding arrangements for the period of the next national health agreement to 2024-25, which will deliver growth in Commonwealth revenue of up to \$1.5 billion for SA public hospitals over this period.

Speaking Note

GST

- GST has been revised up by \$272 million in 2018-19 compared with the estimate contained in the 2017-18 Mid-Year Budget Review.

Cost of living

- Personal income tax cuts for low and middle-income families complement our commitment to lower costs of living for families by:
 - Returning \$90 million per annum through Emergency Services Levy relief
 - Capping council rate rises
 - Lowering electricity bills through improving interconnection, and household and grid scale storage

Skilling Australians Fund

- Total funding included in the Commonwealth Budget for the Skilling Australians Fund National Partnership is broadly in line with previous Commonwealth commitments.

- Funding for the Skilling Australians Fund National Partnership is still subject to some level of uncertainty, given most of the funding will be delivered through a new foreign worker levy. However the budget does include additional funding being made by the Federal Government outside of the levy, including:
 - An additional \$50 million per annum is being guaranteed to be available, with South Australia's share expected to be about \$3.5 million.
 - A once-off amount of \$50 million will be available to be shared amongst states and territories that sign on early to the National Partnership. If all states sign up, South Australia's share is expected to be about \$3.5 million.

Speaking Note

- We will be working with the Federal Government to negotiate the best possible deal for South Australia, and will look to get a share of the additional funding made available.
