APPLICATION UNDER THE FREEDOM OF INFORMATION ACT 1991

I refer to your application made under the *Freedom of Information Act 1991* (FOI Act), dated 3 December, 2018.

Your application seeks access to:

"All correspondence and emails from the South Australian National Football League to the Treasurer, the Hon Rob Lucas MLC and the Treasurer's Office, between 19 March and 30 November 2018."

The purpose of this letter is to advise you of my determination. An extensive search was conducted within this office. Four documents were identified as answering the terms of your application.

I grant you access to 2 documents; copies enclosed. I refuse you access in part to 2 documents.

Documents refused in part

Documents 1 and 3 are both letters written to my office from the SANFL Chief Executive Officer and relates to the club's payroll tax.

Clause 12(1) of Schedule 1 to the FOI Act states that a document is exempt from release if 'it contains matter the disclosure of which would constitute an offence against an Act'. This document contains information obtained in relation to the administration or enforcement of the *Taxation Administration Act 1996* (the TAA), the release of which would be an offence in accordance with Part 9, Division 3, Clause 77 of the TAA.

I have therefore determined these documents are partially exempt pursuant to clause 12(1).

Exemptions

Clause 12 - Secrecy Provisions

(1) A document is an exempt document if it contains matter the disclosure of which would constitute an offence against an Act.

Clause 77 of the TAA – Prohibition of certain disclosures by tax officers

A person who is or has been a tax officer must not disclose any information obtained under or in relation to the administration or enforcement of a taxation law, except as permitted by this Part.

Please note, in compliance with Premier and Cabinet Circular PC045 - Disclosure Logs for Non-Personal Information Released through Freedom of Information (PC045), the Department of Treasury and Finance is now required to publish a log of all non-personal information released under the Freedom of Information Act 1991.

In accordance with this Circular, any non-personal information determined for release as part of this application, may be published on the DTF website. A copy of PC045 can be found at the following address: http://dpc.sa.gov.au/what-we-do/services-for-government/premier-and-cabinet-circulars. Please visit the website for further information.

As I am determining this application as Principal Officer, Section 29(6) of the Act does not provide for an internal review. If you are dissatisfied with my determination you are entitled to exercise your rights of external review with the Ombudsman.

Alternatively, you can apply to the South Australian Civil and Administrative Tribunal. If you wish to seek a review, Section 39(3) of the Act states you must do so within 30 calendar days of receiving the determination.
