APPLICATION UNDER THE FREEDOM OF INFORMATION ACT 1991

I refer to your application made under the *Freedom of Information Act 1991* (the Act), dated 5 August 2020.

Your application seeks access to:

"All minutes, briefings and correspondence titled 'Land Tax Reform – RevenueSA Online System Outage' as described on the Objective document management system, between 9 April and 5 August 2020."

The legislative prescribed timeframe to determine this application has expired and is now deemed to have refused you access to all documents relevant to your application. I refer to my letter dated 18 August 2020 where I sought additional time to make my determination.

The purpose of this letter is to advise you of my determination. An extensive search was conducted within this office. A total of 2 documents were identified as answering the terms of your application.



LAND TAX REFORM - REVENUESA ONLINE SYSTEM OUTAGE

Timing:

ROUTINE — For information only

Recommendations/Issues: It is recommended that you:

- Note the upcoming extended outage to the external facing payroll tax and provision of property certificates functionality within RevenueSA Online from 5pm 30 June 2020 until 8am Monday, 6 July 2020.
- Note the outage is required due to a combination of unique circumstances peculiar
 to this year in addition to the normal property Start of Year (SOY) processing,
 which is to be run concurrently with deployment of system changes to implement
 the land tax reform initiative and payroll tax COVID 19 initiatives.
- Note the SOY processing involves updating the RIO system with SAILIS data and running taxation calculations, to enable the accurate generation of certificates of outstanding tax liability for property owned, as at 30 June 2020.
- Note the communication plan to provide early notification of the outage and strategies to deliver customer service during the outage will begin in the week beginning 8 June 2020.

Key Points:

 System changes in RIO and RevenueSA Online collectively will require an extended outage to the payroll tax lodgement system and the availability of Property Tax Certificates, which are used to provide details of Land Tax and ESL liabilities.



- Based on the current project schedule it is expected that this outage will be required from 5:00 pm Tuesday, 30 June 2020 to 8:00 am Monday, 6 July 2020. A total of five days.
- At the beginning of each financial year for the property tax lines (Land Tax and ESL),
 parcel and ownership data is prepared for calculation of liability. This is known as the
 Start of Year (SOY) process and involves a number of system processes such as
 updating valuations and ownership data and running tax calculations to prepare the
 parcel/ownership data for property tax billing and collection. This process is usually
 run over a weekend.
- During the SOY period, the system (RIO) is unavailable for use resulting in property certificates not being available for purchase and businesses not being able to lodge payroll tax return
- The implementation of the land tax reform in RIO requires a significant deployment of changes to both the live production system and the SOY process, as a result of new more complex taxation calculations and a large volume of aggregation data collected in RevenueSA Online being imported to RIO.
- The implementation of the payroll tax COVID ex gratia relief measures for the 2020/21 payroll tax annual reconciliation requires a significant deployment of changes to both RevenueSA Online and RIO. These changes will be promoted to the RIO production system at the same time as the land tax changes.
- Other applications in RevenueSA Online do not interface to the RIO system and are not impacted by this outage including the Stamp Duty, Small Business Grant and the Land Tax Portal.
- RevenueSA will ensure the system outages are clearly and effectively communicated well in advance of the outage times. Attachment 1 outlines the proposed communication plan.
- Due to the implementation of the payroll tax COVID19 ex gratia measures the 2020/21 payroll tax annual reconciliation will be opened after the scheduled system outage. A revised due date for lodgement has been formally extended to 28 July 2020, to ensure consistency with other jurisdictions as part of the Board of Treasurers harmonisation directive. The impact to external users is expected to be minimal.
- RevenueSA will encourage practitioners requiring property certificates during the
 outage period to make the request in advance. Clients that need to get their
 certificates updated during the outage (generally on or the day before settlement) will
 be able to contact RevenueSA via a dedicated phone number and email address.
 This will alleviate the concerns relating to the high volume of calls currently being
 experienced by the RevenueSA call centre.

 Clients requiring new certificates during the outage will also be able to contact RevenueSA and request a manual certificate.
