APPLICATION UNDER THE FREEDOM OF INFORMATION ACT 1991

I refer to your application made under the *Freedom of Information Act 1991* (the Act), dated 5 August 2020.

Your application seeks access to:

"All minutes, briefings and correspondence titled 'SA Water – Section 6 Direction' as described on the Objective document management system, between 9 April and 5 August 2020."

The prescribed legislative timeframe to determine this application has expired and is now deemed to have refused you access to documents relevant to your application. I refer to my letter dated 18 August 2020 where I sought additional time to make my determination.

The purpose of this letter is to advise you of my determination. An extensive search was conducted within this office. A total of 3 documents were identified as answering the terms of your application.

I grant you access in part to 2 documents; copies of which are enclosed. I refuse in full 1 document.

Documents 1 and 2 are both released in part as disclosure of these documents would divulge information concerning a deliberation of Cabinet. I therefore determine this information exempt pursuant to clause 1(1)(e) to the Act.

Documents Refused in Full

Document 3 is a Section 6 Direction to the South Australian Water Corporation, pursuant to section 6 of the *Public Corporations Act 1993*. This direction was published in the Government Gazette on 11 June 2020 and is publicly available.

Exemptions

 - (e) if it contains matter the disclosure of which would disclose information concerning any deliberation or decision of Cabinet; or


