APPLICATION UNDER THE *FREEDOM OF INFORMATION ACT 1991*

I refer to your application made under the *Freedom of Information Act 1991* (FOI Act), dated 22 February 2019 which was transferred to my office from the Department of Treasury and Finance on the 25 February 2019. I acknowledge your internal review application received on the 27 March 2019.

Your application seeks access to:

"A current index of all briefs held on the Objective document management system (a) Received by the Treasurer's Office; (b) Requested by the Treasurer's Office; (c) Generated by the Treasurer's Office; and (d) Returned to the Department after consideration by the Treasurer or Treasurer's Office staff, between 12 July 2018 and 22 February 2019."

Determination under review

The legislative prescribed timeframe to determine this application has expired and is now deemed to have refused you access to all documents relevant to your application.

Outcome of internal review

A total of 1 document was identified as answering the terms of your application and I have determined as follows:

I grant you access in part to the document. However, certain information has been redacted relating to any personal information on first home owners grant and payroll tax objections, pursuant to clause 12(1) of the FOI Act. Information on briefings which have been provided to myself for use in Cabinet or a Cabinet Committee meeting, or containing Cabinet decisions have been redacted, pursuant to clause 1 of the FOI Act.

Businesses who have applied for Government grants and/or funding have also been removed, pursuant to clause 7(1)(c) of the FOI Act.

A number of briefings are also internal working documents (clause 9(1)(a)(i)) so specific information has been redacted as these documents were prepared internally and contain opinion, advice or recommendations which were considered for the purpose of decision making relating to the functions of Government. On balance, it is not in the public interest to disclose the content of these documents as it is important for the agency to receive frank and comprehensive advice and opinions, including the expression of views which may be contentious.

Personal information relating to sensitive matters relating to payments and settlement issues, involving members of the general public have been redacted pursuant to clause 6(1).

There are also a number of confidential briefings which are subject to legal privilege and the disclosure of which would constitute an offence. This information has been redacted pursuant to clause 10(1) and clause 12(1).

Any briefings relating to intergovernmental relations has also been redacted, pursuant to clause 3(a)(b).

Exemptions

Clause 1 – Cabinet Documents

- (1) *A document is an exempt document—*
- (a) *if it is a document that has been specifically prepared for submission to Cabinet (whether or not it has been so submitted); or*
 - (b) *if it is a preliminary draft of a document referred to in paragraph (a); or*
 - (c) *if it is a document that is a copy of or part of, or contains an extract from, a document referred to in paragraph (a) or (b).*

Clause 3 – Intergovernmental Communications

A document is an exempt document if —

- (a) *It contains information from an intergovernmental communication to the Government of South Australia or a council.*

Clause 6 – Documents affecting personal affairs

- (1) *A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person.*

Clause 7 – Documents affecting business affairs concerning

- (1) *A document is an exempt document—*
- (b) *if it contains matter—*
 - (i) *consisting of information (other than trade secrets) that has a commercial value to any agency or any other person; and*
 - (ii) *the disclosure of which—*

- (A) could reasonably be expected to have an adverse effect on those affairs or to prejudice the future supply of such information to the Government or to an agency; and
- (B) would, on balance, be contrary to the public interest; or
- (c) if it contains matter—
 - (i) consisting of information (other than trade secrets or information referred to in paragraph (b)) concerning the business, professional, commercial or financial affairs of any agency or any other person; and
 - (ii) the disclosure of which—
 - (A) could reasonably be expected to have an adverse effect on those affairs or to prejudice the future supply of such information to the Government or to an agency; and
 - (B) would, on balance, be contrary to the public interest.

Clause 9 — Internal Working Documents

- (1) a document is an exempt document if it contains matter—
 - (a) that relates to—
 - (i) any opinion, advice or recommendation that has been obtained, prepared or recorded; or
 - (ii) any consultation or deliberation that has taken place, in the course of, or for the purpose of, the decision-making functions of the Government, a Minister or an agency; and
 - (b) the disclosure of which would, on balance, be contrary to the public interest.

Clause 10 – Documents subject to legal professional privilege

- (1) A document is an exempt document if it contain matter that would be privileged from production in legal proceedings on the ground of legal professional privilege.

Clause 12 – Secrecy Provisions

- (1) A document is an exempt document if it contains matter the disclosure of which would constitute an offence against an Act.

Clause 77 of the TAA – Prohibition of certain disclosures by tax officers

A person who is or has been a tax officer must not disclose any information obtained under or in relation to the administration or enforcement of a taxation law, except as permitted by this Part.

Clause 17 – Documents subject to contempt etc

A document is an exempt document if it contains matter the public disclosure of which would, but for any immunity of the Crown—

- (c) infringe the privilege of Parliament

Please note, in compliance with Premier and Cabinet Circular PC045 - *Disclosure Logs for Non-Personal Information Released through Freedom of Information* (PC045), the Department of Treasury and Finance is now required to publish a log of all non-personal information released under the *Freedom of Information Act 1991*.


