Freedom of Information - Custom Bus Australia Pty Ltd (Administrators Appointed) ("the Company")

I refer to your application under the *Freedom of Information Act 1991* (FOI Act), received by the Department of Treasury and Finance (DTF) on 19 April 2018.

Your application specifically requested:

'Copies of the following documentation during the period 18 January 2016 to 18 January 2018.

- 1. All correspondence passing between Revenue SA and the Company, including but not limited to notification of outstanding liabilities, running balance account, demands for payment of outstanding liabilities, payment proposals, payment arrangements, financial reports.
- 2. All file notes and diary notes both handwritten and typed
- 3. Revenue SA internal emails; and
- 4. Other documentation and information pertaining to the company that may assist our investigations.'

Under the Act, an agency has 30 days to respond to a freedom of information request. As DTF did not respond to your request within the time frame required, the department is deemed to have refused you access to all documents relevant to your application. However, I have determined to process the request as if the statutory time frame had been met.

The purpose of this letter is to advise you of my determination.

A total of 34 documents were identified as answering the terms of your application and I have determined to release all documents in full.

Please note, in compliance with Premier and Cabinet Circular PC045 - *Disclosure Logs for Non-Personal Information Released through Freedom of Information* (PC045), DTF is now required to publish a log of all non-personal information released under the *Freedom of Information Act 1991*.
