### **Freedom of Information Internal Review — 2019-20 Federal Budget**

I refer to your Freedom of Information application received by the Department of Treasury and Finance on 15 April 2019 and your Internal Review application received on 29 May 2019.

Your applications specifically requested:

*All documents, correspondence, minutes and memos held by the Department of Treasury and Finance regarding the 2019-20 Federal Budget [date range 24/3/2019 to 15/4/2019].*

### **Determination under review**

DTF did not make a determination on your initial application within the 30-day time period required by the Freedom of Information Act 1991 (the Act). Accordingly, DTF was deemed to have refused access in full to all documents relevant to your application.

### **Outcome of internal review**

Under section 29(3) of the FOI Act, on an application for internal review, as principal officer I may, confirm, vary or reverse the determination under review. In doing so, I am required to give fresh consideration to the decision under the FOI Act

I have determined to **vary** the original deemed refusal determination.

A total of 131 documents were identified as answering the terms of the application and DTF determined as follows:

- Access to be granted in full to 76 documents, copies of which are enclosed,
- Access to be granted in part to 8 documents, copies of are enclosed, and
- Refuse access to 47 documents.

Please refer to the attached schedule that describes each document and sets out my determination and reasons in summary form.

### **Documents released in full**

Documents 2 - 3, 5, 7, 14 - 15, 17, 18 - 18a, 19a - 20, 21, 23, 23b - 24, 26, 27, 28 - 33, 45 - 60, 62, 65 - 68, 70 - 75, 77 - 78, 80, 82, 88 - 107

### **Documents released in part**

Documents 1, 4, 19, 34

These documents contains information which, if released, would disclose details concerning a deliberation or decision of Cabinet. I have therefore determined to exempt this information pursuant to clause 1(1)(e).

Document 25

This document is a briefing paper specifically prepared for the use of the Minister in relation to a matter submitted to Cabinet. I have therefore exempted the document pursuant to clause 1(1)(f) of the FOI Act

Documents 9 – 10, 23a

Under clause 5 of Schedule 1 to the Act, information is exempt from disclosure if it contains matter the disclosure of which could reasonably be expected to cause damage to intergovernmental relations; or would divulge information from a confidential intergovernmental communication. These documents contain information that if released could reasonably be expected to adversely affect the development of a proposed agreement between the Commonwealth and States and Territories. The disclosure of this information could also reasonably be expected to negatively impact on the implementation of the proposed agreement. Disclosure of this information could also have an impact on the development and implementation of future Commonwealth-State agreements. Taking all of this into account I have therefore determined to exempt this information pursuant to clause 5.

### **Documents refused in full**

Documents 28a, 32a

These documents are drafts of documents that were specifically prepared for submission to Cabinet. I have therefore recommend to refuse access to these documents pursuant to clause 1(1)(b).

Documents 1a, 1b, 17a, 20a, 22, 26a, 43 – 44

These documents consist of extracts from documents which were submitted to Cabinet and are therefore exempt pursuant to clause 1(1)(c).

Documents 5a – 6a, 8, 12 – 13, 16, 35 – 36, 38 – 42

These documents consist of information which, if released, would disclose details concerning a deliberation or decision of Cabinet and as such is exempt from release pursuant to clause 1(1)(e).

Documents 2a, 3a, 4a, 11, 15a, 63

These documents are briefing papers specifically prepared for the use of the Minister in relation to a matter submitted to Cabinet. I have therefore exempted these documents pursuant to clause 1(1)(f) of the FOI Act.

Documents 33a, 37, 61, 69

These documents were prepared specifically for use in Parliament, the disclosure of which would infringe the privilege of Parliament. I have therefore determined to exempt these documents in full pursuant to clause 17(c) of Schedule 1 to the FOI Act

Documents 25a, 81

Under clause 5 of Schedule 1 to the Act, information is exempt from disclosure if it contains matter the disclosure of which could reasonably be expected to cause damage to intergovernmental relations; or would divulge information from a confidential intergovernmental communication. These documents consist of information that if released could reasonably be expected to adversely affect the development of proposed agreement between the Commonwealth and States and Territories. The disclosure of this information could also reasonably be expected to negatively impact on the implementation of the proposed agreement. Disclosure of this information could also have an impact on the development and implementation of future Commonwealth-State agreements. Taking all of this into account I have therefore determined to exempt these documents pursuant to clause 5.

Documents 27a, 29a, 64, 76, 79, 83 – 87, 108

Having regard to the content of the communication, it is my view that the documents contain matter that relates to opinion and advice obtained and consultation that has taken place in the course of decision-making in relation to the negotiations.

I acknowledge that there is a strong public interest around the government's decision making. In my view, however, this is outweighed by the need to ensure that public servants are able to provide advice without inhibiting frankness and candour. Disclosure of these documents would hinder free communication and would, in turn, impede the agency's deliberative process. On balance, I consider that the release of this information would be contrary to the public interest, and I have therefore determined these documents to be exempt pursuant to clause 9(1)(a)(i) of the FOI Act.

## **Exemptions**

### **Clause 1 – Cabinet documents**

- (1) *A document is an exempt document –*
  - (a) *if it is a preliminary draft of a document referred to in paragraph (1); or*
  - (e) *if it contains matter the disclosure of which would disclose information concerning any deliberation or decision of Cabinet; or*
  - (f) *if it is a briefing paper specifically prepared for the use of a Minister in relation to a matter submitted, or proposed to be submitted to Cabinet.*

### **Clause 5 – Documents affecting inter-governmental or local governmental relations**

- (1) *A document is an exempt document if it contains matter—*
  - (a) *the disclosure of which—*
    - (i) *could reasonably be expected to cause damage to intergovernmental relations;*  
*or*
    - (ii) *would divulge information from a confidential intergovernmental communication; and*
  - (b) *the disclosure of which would, on balance, be contrary to the public interest.*



**Clause 9 – Internal working documents**

(1) A document is an exempt document if it contains matter—

(a) that relates to—

- (i) any opinion, advice or recommendation that has been obtained, prepared or recorded; or
- (ii) any consultation or deliberation that has taken place, in the course of, or for the purpose of, the decision-making functions of the Government, a Minister or an agency; and

(b) the disclosure of which would, on balance, be contrary to the public interest.

**Clause 17 – Documents subject to contempt etc**

A document is an exempt document if it contains matter the public disclosure of which would, but for any immunity of the Crown—

...

(c) infringe the privilege of Parliament
