APPLICATION UNDER THE FREEDOM OF INFORMATION ACT 1991

I refer to your application made under the *Freedom of Information Act 1991* (the Act), dated 17 April, 2021.

Your application seeks access to:

"All documents, briefings and emails produced or received by the Hon Rob Lucas MP, Gino De Gennaro, Julian Robertson, Sue Lees, Luigi Mesisca and Nino Marciano in the Office of the Treasurer to or from Ms Inthira Stocker regarding FOI applications." From 1 January 2021 to 17 April 2021.

The purpose of this letter is to advise you of my determination. An extensive search was conducted within the scope of your application. A total of 37 documents were identified as answering the terms of your application.

I grant you access in full to 6 documents; copies of which are enclosed. I grant you access in part to 20 documents; copies of which are enclosed. I refuse in full 11 documents.

Documents Released in Full

Documents 1, 2, 11, 16, 26, and 30.

Documents Released in Part

Documents 6, 7, 8, 9, 12, 13, 14, 17, 18, 19, 21, 22, 23, 24, 27, 31, 34, 35, 36 and 37.

Documents Refused in Full

Document 3, 4, 5, 10, 15, 20, 25, 28, 29, 32 and 33.

Clause 12(1) of Schedule 1 to the FOI Act states that a document is exempt from release if 'it contains matter the disclosure of which would constitute an offence against an Act'.

Documents 6, 7, 8, 9, 10, 12, 13, 14, 15, 17, 18, 19, and 20 contain information obtained in relation to the administration or enforcement of the *Taxation Administration Act 1996* (the TAA), the release of which would be an offence in accordance with section 78 of the TAA.

Documents 21, 22, 23, 24, 25, 34, 35, 36 and 37 contain information obtained by SafeWork SA inspectors in the course of exercising their powers and functions under the *Work Health and Safety Act 2012* (the WHS Act), the release of which would be an offence under section 271 of the WHS Act. I have therefore determined to exempt this information pursuant to clause 12(1) of Schedule 1 to the FOI Act.

Documents 7, 8, 12, 13, 17, 18, 22, 23, 27, 31, 35 and 36 contain personal information relating to names and contact details of the FOI applicants, which have been redacted pursuant to clause 6(1).

Documents 3, 4, 5, 28, 29, 32 and 33 are FOI determination letters that are publicly available on the Department of Treasury and Finance's website.

Exemptions

Clause 6 – Documents affecting personal affairs

(1) A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person.

Clause 12 – Secrecy Provisions

(1) A document is an exempt document if it contains matter the disclosure of which would constitute an offence against an Act.

Section 271 of the WHS Act—Confidentiality of information

- (1) This section applies if a person obtains information or gains access to a document in exercising any power or function under this Act (other than under Part 7).
- (2) The person must not do any of the following:
 - a. disclose to anyone else
 - i. the information; or
 - ii. the contents of or information contained in the document;
 - b. give access to the document to anyone else;
 - c. use the information or document for any purpose. ..
- (3) Subsection (2) does not apply to the disclosure of information, or the giving of access to a document or the use of information or a document
 - a. about a person, with the person's consent; or
 - b. that is necessary for the exercise of a power or function under the Act; ...

Clause 78 of the TAA – Permitted disclosure in particular circumstances or to particular persons

A tax officer may disclose information obtained under or in relation to the administration or enforcement of a taxation law—

- (a) with the consent of the person to whom the information relates or at the request of a person acting on behalf of the person to whom the information relates; or
- (b) in connection with the administration or enforcement of a taxation law, the Petroleum Products Regulation Act 1995 or a law of a recognised jurisdiction relating to taxation; or
- (c) for the purposes of legal proceedings under a law referred to in paragraph (b) or reports of such proceedings; or
- (d) to the holder of a prescribed office or a prescribed body established under a law of this jurisdiction or a recognised jurisdiction; or
- (e) as authorised under this Act or the regulations.

Please note, in compliance with Premier and Cabinet Circular PC045 - Disclosure Logs for Non-Personal Information Released through Freedom of Information (PC045), the Department of Treasury and Finance is now required to publish a log of all non-personal information released under the Act.

In accordance with this Circular, any non-personal information determined for release as part of this application, may be published on the DTF website. A copy of PC045 can be found at the following address: https://dpc.sa.gov.au/resources-and-publications/premier-and-cabinet-circulars. Please visit the website for further information.

As I am determining this application as Principal Officer, section 29(6) of the Act does not provide for an internal review. If you are dissatisfied with my determination you are entitled to exercise your rights of external review with the Ombudsman.

Alternatively, you can apply to the South Australian Civil and Administrative Tribunal. If you wish to seek a review, section 39(3) of the Act states you must do so within 30 calendar days of receiving the determination.







I refer to your application under the *Freedom of Information Act 1991* (FOI Act), received by the Department of Treasury and Finance (DTF) requesting access to:

'Information in relation to taxation affairs and [Revenue SA's] dealings with the company for the period from 1 July 2017 to now: 1. running balance account statement, 2. all inbound and outbound correspondence (including correspondence to/from the Company's tax agents, directors and advisors), 3. all your case notes, including telephone call logs, and 4. any other notes, correspondence, demands, lodgements and/or returns.'

Under the Act, an agency has 30 days to respond to a freedom of information request. As DTF did not respond to your request within the time frame required, the department is deemed to have refused you access to all documents relevant to your application. However, I have determined to process the request as if the statutory time frame had been met.

The purpose of this letter is to advise you of my determination.

A total of 86 documents were identified as answering the terms of your application and I have determined as follows:

- I grant you access in full to 85 documents, copies of which are enclosed, and
- I grant you access in part to 1 documents, a copy of which is enclosed.
